## CONCURRENT RESOLUTION

Directing the President, pursuant to section 5(c) of the War Powers Resolution, to remove United States Armed Forces from hostilities with Iran.

1        *Resolved by the House of Representatives (the Senate*  
2        *concurring),*

3        **SECTION 1. TERMINATION OF USE OF FORCE.**

4        (a) **TERMINATION.**—Pursuant to section 5(c) of the  
5 War Powers Resolution (50 U.S.C. 1544(c)), Congress  
6 hereby directs the President to remove the use of the  
7 United States Armed Forces from hostilities against the  
8 Islamic Republic of Iran or any part of its government  
9 or military, including potential ground forces in a combat  
10 role or used for occupation, unless explicitly authorized by

1 a declaration of war or specific authorization for use of  
2 military force against Iran.

3 (b) RULE OF CONSTRUCTION.—Nothing in this sec-  
4 tion may be construed to—

5 (1) prevent the United States from defending  
6 itself, its Armed Forces, its diplomatic facilities, or  
7 allied states from imminent attack;

8 (2) prevent the United States Armed Forces  
9 from maintaining a troop presence in the region for  
10 defensive purposes; or

11 (3) force the removal of the United States  
12 Armed Forces in the region who are not engaged in  
13 hostilities against Iran.

14 **SEC. 2. RULE OF CONSTRUCTION RELATING TO INTEL-**  
15 **LIGENCE SHARING.**

16 Nothing in this resolution may be construed to influ-  
17 ence or disrupt any intelligence, counterintelligence, or in-  
18 vestigative activities relating to threats in or emanating  
19 from Iran or surrounding countries conducted by, or in  
20 conjunction with, the United States Government involv-  
21 ing—

22 (1) the collection of intelligence;

23 (2) the analysis of intelligence; or

24 (3) the sharing of intelligence between the  
25 United States and any coalition partner, if the

1       President determines such sharing is appropriate  
2       and in the national security interests of the United  
3       States.

4 **SEC. 3. RULE OF CONSTRUCTION RELATING TO NON-**  
5                   **AUTHORIZATION OF THE USE OF MILITARY**  
6                   **FORCE.**

7       Consistent with section 8(a)(1) of the War Powers  
8       Resolution (50 U.S.C. 1547(a)(1)), nothing in this concur-  
9       rent resolution may be construed as authorizing the use  
10      of military force.
