## AN ACT

To require public elementary and secondary schools to disclose certain funds received from, or contracts with, a foreign source, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Combating the Lies  
3 of Authoritarians in School Systems Act” or the “CLASS  
4 Act”.

5 **SEC. 2. DISCLOSURE OF FOREIGN FUNDING AND CON-**  
6 **TRACTS.**

7 (a) IN GENERAL.—As a condition on receipt of Fed-  
8 eral financial assistance under any applicable program by  
9 a public elementary school or a public secondary school,  
10 the school, not later than 30 days after receiving funds  
11 in excess of \$10,000 in the aggregate from a foreign  
12 source, or entering into one or more contracts with an ag-  
13 gregate value in excess of \$10,000 with a foreign source,  
14 shall submit to the Secretary of Education a written dis-  
15 closure that identifies—

16 (1) the name and country of origin of the for-  
17 eign source;

18 (2) in a case in which a school receives funds  
19 from a foreign source—

20 (A) the amount of funds received from  
21 that source; and

22 (B) any terms or conditions applicable to  
23 the receipt of such funds; and

24 (3) in a case in which a school enters into a  
25 contract with a foreign source, the terms and condi-  
26 tions of such contract.

1 (b) DEFINITIONS.—In this section:

2 (1) The term “applicable program” has the  
3 meaning given that term in section 400 of the Gen-  
4 eral Education Provisions Act (20 U.S.C. 1221).

5 (2) The terms “elementary school” and “sec-  
6 ondary school” have the meanings given those terms  
7 in section 8101 of the Elementary and Secondary  
8 Education Act of 1965 (20 U.S.C. 7801).

9 (3) The term “Federal financial assistance” has  
10 the meaning given that term in section 7501(a)(5)  
11 of title 31, United States Code.

12 (4) The term “foreign source” has the meaning  
13 given that term in section 117(h) of the Higher  
14 Education Act of 1965 (20 U.S.C. 1011f(h)).
