A BILL

To ensure that parents are aware of foreign influence in their child's public school, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Transparency in Re-*
5 *porting of Adversarial Contributions to Education Act” or*
6 *the “TRACE Act”.*

7 **SEC. 2. PARENTS’ RIGHT TO KNOW ABOUT FOREIGN INFLU-**
8 **ENCE.**

9 *(a) IN GENERAL.—Subpart 2 of part F of title VIII*
10 *of the Elementary and Secondary Education Act of 1965*
11 *(20 U.S.C. 7901 et seq.) is amended by adding at the end*
12 *the following:*

13 **“SEC. 8549D. PARENTS’ RIGHT TO KNOW ABOUT FOREIGN**
14 **INFLUENCE.**

15 *“(a) IN GENERAL.—As a condition of receiving funds*
16 *under this Act, a local educational agency shall ensure that*
17 *each elementary school and each secondary school served by*
18 *such agency provides to each parent of a child attending*
19 *the school, at a minimum—*

20 *“(1) the right (in a manner consistent with*
21 *copyright law) to review, and make copies of free of*
22 *cost, at least every four weeks and not later than 30*
23 *days after submission of a written request by the par-*
24 *ent, any curricular material or professional develop-*
25 *ment material used at the school that was purchased,*

1 *or otherwise obtained, using funds received from the*
2 *government of a foreign country or a foreign entity*
3 *of concern;*

4 *“(2) the right to know, by written response pro-*
5 *vided not later than 30 days after submission of a*
6 *written request by the parent, how many personnel of*
7 *the school are compensated, in whole or in part, using*
8 *funds received from the government of a foreign coun-*
9 *try or a foreign entity of concern; and*

10 *“(3) the right to know, by written response pro-*
11 *vided not later than 30 days after submission of a*
12 *written request by the parent, of—*

13 *“(A) any donation received by the school or*
14 *local educational agency from a foreign country*
15 *or a foreign entity of concern;*

16 *“(B) any agreement in writing (such as a*
17 *contract or memorandum of understanding) be-*
18 *tween the school or local educational agency and*
19 *a foreign country or a foreign entity of concern;*
20 *and*

21 *“(C) any financial transaction between the*
22 *school or local educational agency and a foreign*
23 *country or a foreign entity of concern.*

1 “(b) *DONATIONS, AGREEMENTS, AND FINANCIAL*
2 *TRANSACTIONS.*—*The information described in subsection*
3 *(a)(3) shall include, at minimum, the following:*

4 “(1) *The name of the foreign country or foreign*
5 *entity of concern.*

6 “(2) *In any case in which funds were received by*
7 *the school or local educational agency from a foreign*
8 *country or a foreign entity of concern—*

9 “(A) *the amount of such funds; and*

10 “(B) *any terms or conditions applicable to*
11 *the receipt of such funds.*

12 “(c) *NOTICE OF RIGHTS.*—*At the beginning of each*
13 *school year, a local educational agency receiving funds*
14 *under this Act shall ensure that each elementary school and*
15 *each secondary school served by such agency posts on a pub-*
16 *licly accessible website of the school or, if the school does*
17 *not operate a website, widely disseminates to the public, a*
18 *summary notice of the rights of parents described in sub-*
19 *sections (a) and (b).*

20 “(d) *NOTIFICATION OF REQUIREMENTS.*—*At the begin-*
21 *ning of each school year, the Secretary shall notify State*
22 *educational agencies about the requirements of this section.*
23 *As a condition of receiving funds under this Act, State edu-*
24 *cational agencies shall, at the beginning of each school year,*

1 *notify local educational agencies of the requirements of this*
2 *section.*

3 “(e) *DEFINITIONS.—In this section:*

4 “(1) *The term ‘foreign country’ means a foreign*
5 *country or a dependent territory or possession of a*
6 *foreign country. Such term does not include any of*
7 *the outlying areas.*

8 “(2) *The term ‘foreign entity of concern’ has the*
9 *meaning given such term in section 10612(a) of the*
10 *Research and Development, Competition, and Innova-*
11 *tion Act (42 U.S.C. 19221(a)).”*

12 (b) *TABLE OF CONTENTS.—The table of contents in*
13 *section 2 of the Elementary and Secondary Education Act*
14 *of 1965 is amended by inserting after the item relating to*
15 *section 8549C the following:*

“Sec. 8549D. Parents’ right to know about foreign influence.”
