## A BILL

To amend the Food and Nutrition Act of 2008 to modify work requirements under the supplemental nutrition assistance program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Let’s Get to Work  
5 Act of 2025”.

6 **SEC. 2. SNAP WORK REQUIREMENTS.**

7 (a) IN GENERAL.—Section 6(o) of the Food and Nu-  
8 trition Act of 2008 (7 U.S.C. 2015(o)) is amended—

1           (1) in paragraph (2), in the matter preceding  
2           subparagraph (A), by inserting “, or, in the case of  
3           a parent or other member of a household with re-  
4           sponsibility for a dependent child, 6 months (con-  
5           secutive or otherwise),” before “during which”;

6           (2) in paragraph (3)—

7           (A) in subparagraph (A), by striking  
8           clause (ii) and inserting the following:

9           “(ii) over 60 years of age;”;

10          (B) in subparagraph (C), by inserting  
11          “under 6 years of age” before the semicolon at  
12          the end;

13          (C) in subparagraph (G), by striking “or”  
14          at the end;

15          (D) in subparagraph (H), by striking the  
16          period at the end and inserting “; or”; and

17          (E) by adding at the end the following:

18          “(I)(i) responsible for a dependent indi-  
19          vidual; and

20          “(ii) married to, and resides with, an indi-  
21          vidual who is in compliance with the require-  
22          ments of paragraph (2).”; and

23          (3) in paragraph (6)—

24          (A) in subparagraph (B), by striking “(I)”  
25          and inserting “(H)”;

1 (B) in subparagraph (C), by striking “(G)  
2 and (I)” and inserting “(F) and (H)”;

3 (C) in subparagraph (D), by striking “(G)  
4 through (I)” and inserting “(F) through (H)”;

5 (D) by striking subparagraph (F);

6 (E) by redesignating subparagraphs (G)  
7 through (J) as subparagraphs (F) through (I),  
8 respectively; and

9 (F) in subparagraph (F) (as so redesign-  
10 nated), by striking “(C), (D), (E), or (F)” and  
11 inserting “(C), (D), or (E)”.

12 (b) CONFORMING AMENDMENT.—Section  
13 16(h)(1)(E)(ii)(I) of the Food and Nutrition Act of 2008  
14 (7 U.S.C. 2025(h)(1)(E)(ii)(I)) is amended by striking “3-  
15 month period” and inserting “3-month or 6-month period,  
16 as applicable.”.

17 **SEC. 3. WORK REQUIREMENTS FOR PUBLIC HOUSING AND**  
18 **TENANT-BASED RENTAL ASSISTANCE.**

19 (a) PUBLIC HOUSING.—Section 3 of the United  
20 States Housing Act of 1937 (42 U.S.C. 1437a) is amend-  
21 ed by adding at the end the following:

22 “(e) WORK REQUIREMENTS FOR FAMILIES.—The re-  
23 quirements described in section 6(o) of the Food and Nu-  
24 trition Act of 2008 (7 U.S.C. 2015(o)) shall apply with  
25 respect to any individual who—

1           “(1) is a member of a family residing in a pub-  
2           lic housing dwelling; and

3           “(2) is not exempted from those requirements  
4           under paragraph (3) of such section.”.

5           (b) TENANT-BASED RENTAL ASSISTANCE.—Section  
6           8(o) of the United States Housing Act of 1937 (42 U.S.C.  
7           1437f(o)) is amended by adding at the end the following:

8           “(22) WORK REQUIREMENTS FOR FAMILIES.—  
9           The requirements described in section 6(o) of the  
10          Food and Nutrition Act of 2008 (7 U.S.C. 2015(o))  
11          shall apply with respect to any individual who—

12                   “(A) is a member of a family receiving ten-  
13                   ant-based assistance; and

14                   “(B) is not exempted from those require-  
15                   ments under paragraph (3) of such section.”.
