Mr. BIGGS of Arizona introduced the following bill; which was referred to the Committee on Oversight and Government Reform, and in addition to the Committees on House Administration, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To prohibit COVID–19 vaccination mandates, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Mandates Act”.

5 **SEC. 2. PROHIBITION ON AGENCIES ISSUING VACCINE**
6 **MANDATES.**

7 (a) IN GENERAL.—No agency may issue any rule,
8 regulations, or guidance requiring any individual to receive
9 a vaccination for COVID–19.

1 (b) AGENCY DEFINED.—In this section, the term
2 “agency” has the meaning given that term in section 551
3 of title 5, United States Code.

4 **SEC. 3. PROHIBITION ON REQUIRING PROOF OF COVID-19**
5 **VACCINATION FOR FEDERAL ACCESS.**

6 A vaccination for COVID–19 shall not be required
7 for access to Federal property or Federal services, or for
8 access to congressional grounds or services.

9 **SEC. 4. FEDERAL FUNDING RESTRICTIONS.**

10 (a) FUNDING RESTRICTION.—No entity that received
11 Federal funds under a COVID–19 relief package or that
12 receives any other Federal funds after the date of the en-
13 actment of this Act may require any individual to have
14 received a vaccination for COVID–19 as a condition of
15 such entity providing any service to such individual.

16 (b) RETURN OF FUNDS.—Any entity that does not
17 comply with subsection (a) shall be required to pay to the
18 Government an amount equal to the sum of all funds such
19 entity received.

20 (c) COVID–19 RELIEF PACKAGE DEFINED.—In this
21 section, the term “COVID–19 relief package” means any
22 of the following:
