AN ACT

To designate the General George C. Marshall House, in the Commonwealth of Virginia, as an affiliated area of the National Park System, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. ESTABLISHMENT OF THE GENERAL GEORGE C.**
2 **MARSHALL HOUSE AS AN AFFILIATED AREA.**

3 (a) IN GENERAL.—The General George C. Marshall
4 House, in the Commonwealth of Virginia, is established
5 as an affiliated area of the National Park System.

6 (b) DESCRIPTION OF AFFILIATED AREA.—The affli-
7 ated area shall consist of the area generally depicted as
8 the “General George C. Marshall House Property, Lees-
9 burg, Virginia” on the map titled “General George C.
10 Marshall House, Proposed Affiliated Area”, numbered
11 999/189,974, and dated September 2023.

12 (c) ADMINISTRATION.—The affiliated area shall be
13 managed in a manner consistent with—

14 (1) this Act; and

15 (2) any law generally applicable to units of the
16 National Park System.

17 (d) MANAGEMENT ENTITY.—The George C. Marshall
18 International Center shall be the management entity for
19 the affiliated area.

20 (e) AGREEMENTS.—The Secretary of the Interior (re-
21 ferred to in this section as the “Secretary”)—

22 (1) may provide technical assistance and enter
23 into cooperative agreements with the management
24 entity for the purpose of providing financial assist-
25 ance for the marketing, marking, interpretation, and
26 preservation of the affiliated area; and

1 (2) shall enter into an agreement with the man-
2 agement entity that delineates the roles and respon-
3 sibilities for the management of the area consistent
4 with the policies and standards that apply to units
5 of the National Park System.

6 (f) LIMITED ROLE OF THE SECRETARY.—Nothing in
7 this Act authorizes the Secretary to acquire property at
8 the affiliated area or to assume managerial or financial
9 responsibility for the operation, maintenance, or manage-
10 ment of the affiliated area.

11 (g) PRIVATE PROPERTY PROTECTION.—Nothing in
12 this Act affects the land use rights of private property
13 owners adjacent to the General George C. Marshall House.

14 (h) NO BUFFER ZONES.—

15 (1) IN GENERAL.—Nothing in this Act shall be
16 construed to create buffer zones outside of the Gen-
17 eral George C. Marshall House.

18 (2) ACTIVITY OR USE OUTSIDE THE GENERAL
19 GEORGE C. MARSHALL HOUSE.—The fact that an ac-
20 tivity or use can be seen, heard, or detected from
21 within the George C. Marshall House shall not pre-
22 clude, limit, control, regulate, or determine the con-
23 duct or management of activities or uses outside of
24 the George C. Marshall House.

1 (i) MANAGEMENT PLAN.—Not later than 3 years
2 after the date on which funds are made available to carry
3 out this section, the Secretary, in consultation with the
4 management entity, shall complete a management plan for
5 the affiliated area in accordance with section 100502 of
6 title 54, United States Code.
