## AN ACT

To make daylight savings time permanent, and for other  
purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “Sunshine Protection  
3 Act of 2025”.

4 **SEC. 2. MAKING DAYLIGHT SAVINGS TIME PERMANENT.**

5       (a) REPEAL OF TEMPORARY PERIOD FOR DAYLIGHT  
6 SAVINGS TIME.—Section 3 of the Uniform Time Act of  
7 1966 (15 U.S.C. 260a) is hereby repealed.

8       (b) ADVANCEMENT OF STANDARD TIME.—

9           (1) IN GENERAL.—The second sentence of sub-  
10 section (a) of section 1 of the Act of March 19,  
11 1918 (commonly known as the “Calder Act”) (15  
12 U.S.C. 261), is amended—

13                   (A) by striking “4 hours” and inserting “3  
14 hours”;

15                   (B) by striking “5 hours” and inserting “4  
16 hours”;

17                   (C) by striking “6 hours” and inserting “5  
18 hours”;

19                   (D) by striking “7 hours” and inserting “6  
20 hours”;

21                   (E) by striking “8 hours” and inserting  
22 “by 7 hours”;

23                   (F) by striking “9 hours” and inserting “8  
24 hours”;

25                   (G) by striking “10 hours;” and inserting  
26 “9 hours;”;

1 (H) by striking “11 hours” and inserting  
2 “10 hours”; and

3 (I) by striking “10 hours.” and inserting  
4 “11 hours.”.

5 (2) STATE EXEMPTION.—Such section is fur-  
6 ther amended by—

7 (A) redesignating subsection (b) as sub-  
8 section (c); and

9 (B) inserting after subsection (a) the fol-  
10 lowing:

11 “(b) STANDARD TIME FOR CERTAIN STATES AND  
12 AREAS.—The standard time for a State that has exempted  
13 itself from the provisions of section 3(a) of the Uniform  
14 Time Act of 1966 (15 U.S.C. 260a(a)), as in effect on  
15 the day before the date of the enactment of the Sunshine  
16 Protection Act of 2025, pursuant to such section, or an  
17 area of a State that has exempted such area from such  
18 provisions pursuant to such section, shall be, as such State  
19 considers appropriate—

20 “(1) the standard time for such State or area,  
21 as the case may be, pursuant to subsection (a) of  
22 this section; or

23 “(2) the standard time for such State or area,  
24 as the case may be, pursuant to subsection (a) of  
25 this section as it was in effect on the day before the

1 date of the enactment of the Sunshine Protection  
2 Act of 2025.”.

3 (3) CONFORMING AMENDMENT.—Such section  
4 is further amended, in the second sentence of sub-  
5 section (a), by striking “Except as provided in sec-  
6 tion 3(a) of the Uniform Time Act of 1966 (15  
7 U.S.C. 260a),” and inserting “Except as provided in  
8 subsection (b),”.
