AN ACT

To ban the sale of products with a high concentration of sodium nitrite to individuals, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This title may be cited as the “Youth Poisoning Pro-
5 tection Act”.

6 **SEC. 2. BANNING OF PRODUCTS CONTAINING A HIGH CON-**
7 **CENTRATION OF SODIUM NITRITE.**

8 (a) IN GENERAL.—Any consumer product containing
9 a high concentration of sodium nitrite shall be considered

1 to be a banned hazardous product under section 8 of the
2 Consumer Product Safety Act (15 U.S.C. 2057).

3 (b) RULE OF CONSTRUCTION.—Nothing in this sec-
4 tion shall be construed to—

5 (1) prohibit any commercial or industrial pur-
6 pose in which high concentration sodium nitrite is
7 not customarily produced or distributed for sale to,
8 or use or consumption by, or enjoyment of, a con-
9 sumer; and

10 (2) apply to high concentration sodium nitrite
11 that meets the definition of a drug, device, or cos-
12 metic (as such terms are defined in subsections (g),
13 (h), and (i) of section 201 of the Federal Food,
14 Drug, and Cosmetic Act (21 U.S.C. 321(g), (h), and
15 (i))), or food (as defined in section 201(f) of such
16 Act (21 U.S.C. 321(f))), including poultry and poul-
17 try products (as such terms are defined in sub-
18 sections (e) and (f) of section 4 of the Poultry Prod-
19 ucts Inspection Act (21 U.S.C. 453(e) and (f))),
20 meat and meat food products (as such terms are de-
21 fined in section 1(j) of the Federal Meat Inspection
22 Act (21 U.S.C. 601(j))), and eggs and egg products
23 (as such terms are defined in section 4 of the Egg
24 Products Inspection Act (21 U.S.C. 1033)).

25 (c) DEFINITIONS.—For purposes of this section:

(2) HIGH CONCENTRATION OF SODIUM NITRITE.—The term “high concentration of sodium nitrite” means a concentration of 10 or more percent by weight of sodium nitrite.

9 (d) EFFECTIVE DATE.—This section shall take effect
10 90 days after the date of enactment of this Act.
