# **A BILL**

To amend title 38, United States Code, to promote assistance from persons recognized by the Secretary of Veterans Affairs for individuals who file certain claims under laws administered by the Secretary.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Veterans Claims Edu-*  
 5       *cation Act of 2025”.*

6       **SEC. 2. PROMOTION OF ASSISTANCE FROM PERSONS REC-**  
 7                       **OGNIZED BY THE SECRETARY OF VETERANS**  
 8                       **AFFAIRS FOR INDIVIDUALS WHO FILE CER-**  
 9                       **TAIN CLAIMS UNDER LAWS ADMINISTERED**  
 10                      **BY THE SECRETARY.**

11       *(a) NOTICE TO CLAIMANTS OF AVAILABLE ASSISTANCE*  
 12       *FROM RECOGNIZED PERSONS.—Section 5103A of title 38,*  
 13       *United States Code, is amended—*

14               *(1) by redesignating subsections (g) through (i)*  
 15       *as subsections (i) through (k), respectively;*

16               *(2) by inserting after subsection (f) the following*  
 17       *new subsections:*

18       *“(g) Upon receipt of an initial claim by a claimant*  
 19       *not represented by an accredited person, the Secretary shall*  
 20       *provide notice to the claimant that—*

21               *“(1) an accredited person may be able to rep-*  
 22       *resent the claimant;*

23               *“(2) a veterans service organization recognized*  
 24       *under section 5902 of this title may represent the*  
 25       *claimant at no charge to the claimant;*

1           “(3) provides the web address of the online tool  
2           maintained under subsection (h); and

3           “(4) provides the web address of an appropriate  
4           and publicly accessible website of the Department  
5           through which a claimant may report—

6                       “(A) a person, who is not an accredited per-  
7                       son, who represented the claimant; and

8                       “(B) any fee charged by such person for  
9                       such representation.

10          “(h)(1) The Secretary shall maintain an online tool  
11          that allows a claimant to search a list of accredited persons  
12          who represent claimants.

13          “(2) The Secretary shall ensure that such list is cur-  
14          rent at least once each calendar quarter.

15          “(3) The Secretary shall ensure that such tool is easily  
16          accessible to a claimant.”; and

17               (3) by adding at the end the following new sub-  
18          section:

19          “(l) In this section:

20               “(1) The term ‘accredited person’ means—

21                       “(A) a veterans service organization recog-  
22                       nized under section 5902 of this title; or

23                       “(B) an attorney, agent, or other person  
24                       recognized under section 5904 of this title.

1           “(2) The term ‘represent’ means to prepare,  
2           present, or prosecute a claim under a law adminis-  
3           tered by the Secretary on behalf of a claimant.”.

4           (b) *ONLINE INFORMATION REGARDING PERSONS THAT*  
5 *ASSIST CLAIMANTS.*—*The Secretary of Veterans Affairs*  
6 *shall include, in each web portal of the Department of Vet-*  
7 *erans Affairs, through which an individual may file a claim*  
8 *for a benefit administered by the Under Secretary for Bene-*  
9 *fits or the Under Secretary for Health, a warning regarding*  
10 *fees an agent or attorney may charge such individual for*  
11 *assistance in filing such claim. Such warning shall include*  
12 *the following:*

13           (1) *A link to the online tool maintained under*  
14 *subsection (h) of section 5103A of such title, as*  
15 *amended by subsection (a).*

16           (2) *A link to the website of the Department de-*  
17 *scribed in subparagraph (D) of section 5103A(f)(1) of*  
18 *such title, as amended by subsection (a).*

19           (c) *REPORT.*—*Not later than 180 days after the date*  
20 *of the enactment of this Act, the Secretary shall—*

21           (1) *complete a review the regulations, processes,*  
22 *and procedures of the Department of Veterans Affairs*  
23 *that pertain to recognition under section 5904 of title*  
24 *38, United States Code;*

1           (2) *develop recommendations for legislative or*  
2           *administrative action to improve such regulations,*  
3           *processes, and procedures; and*

4           (3) *submit to the Committees on Veterans' Af-*  
5           *fairs of the Senate and House of Representatives a re-*  
6           *port containing the findings of the Secretary with re-*  
7           *spect to the review completed under paragraph (1)*  
8           *and the recommendations developed under paragraph*  
9           *(2).*

10 **SEC. 3. EXTENSION OF CERTAIN LIMITS ON PAYMENTS OF**  
11 **PENSION.**

12           *Section 5503(d)(7) of title 38, United States Code, is*  
13 *amended by striking “November 30, 2031” and inserting*  
14 *“March 31, 2032”.*
