A BILL

To amend the Immigration and Nationality Act with respect to aliens who carried out, participated in, planned, financed, supported, or otherwise facilitated the attacks against Israel.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “No Immigration Bene-*
 5 *fits for Hamas Terrorists Act of 2025”.*

6 **SEC. 2. ALIENS WHO CARRIED OUT, PARTICIPATED IN,**
 7 **PLANNED, FINANCED, SUPPORTED, OR OTH-**
 8 **ERWISE FACILITATED ATTACKS AGAINST**
 9 **ISRAEL.**

10 *(a) PARTICIPANTS IN HAMAS TERRORISM AGAINST*
 11 *ISRAEL.—Section 212(a)(3) of the Immigration and Na-*
 12 *tionality Act (8 U.S.C. 1182(a)(3)) is amended—*

13 *(1) in subparagraph (B)(i), in the matter fol-*
 14 *lowing subclause (IX)—*

15 *(A) by inserting “Palestinian Islamic*
 16 *Jihad, or Hamas” after “Palestine Liberation*
 17 *Organization”; and*

18 *(B) by inserting “member,” after “rep-*
 19 *resentative,”; and*

20 *(2) by adding at the end the following:*

21 *“(H) PARTICIPANTS IN HAMAS TERRORISM*
 22 *AGAINST ISRAEL.—Any alien who carried out,*
 23 *participated in, planned, financed, afforded ma-*
 24 *terial support to, or otherwise facilitated any of*

1 *the attacks against Israel initiated by Hamas be-*
2 *ginning on October 7, 2023, is inadmissible.”.*

3 **(b) INELIGIBILITY FOR RELIEF.**—Section 241(b)(3) of
4 *the Immigration and Nationality Act (8 U.S.C. 1231(b)(3))*
5 *is amended by adding at the end the following:*

6 **“(D) INELIGIBILITY FOR RELIEF.**—*Any*
7 *alien who carried out, participated in, planned,*
8 *financed, afforded material support to, or other-*
9 *wise facilitated any of the attacks against Israel*
10 *initiated by Hamas beginning on October 7,*
11 *2023, shall be ineligible for any relief under the*
12 *immigration laws, including under this section,*
13 *section 208, and section 2242 of the Omnibus*
14 *Consolidated and Emergency Supplemental Ap-*
15 *propriations Act, 1999 (and any regulations*
16 *issued pursuant to such section).”.*

17 **(c) CONFORMING AMENDMENT.**—Section 237(a)(4)(B)
18 *of the Immigration and Nationality Act (8 U.S.C.*
19 *1227(a)(4)(B)) is amended by striking “subparagraph (B)*
20 *or (F)” and inserting “subparagraph (B), (F), or (H)”.*

21 **(d) REPORT REQUIRED ON PARTICIPANTS IN HAMAS**
22 **TERRORISM AGAINST ISRAEL.**—*Beginning not later than*
23 *one year after the date of the enactment of this Act, and*
24 *each year thereafter, the Secretary of Homeland Security*

1 *shall submit a report to Congress, including the number of*
2 *aliens who were—*

3 *(1) found to be inadmissible under section*
4 *212(a)(3)(H) of the Immigration and Nationality Act*
5 *(8 U.S.C. 1182(a)(3)(H)); and*

6 *(2) described in section 212(a)(3)(H) of the Im-*
7 *migration and Nationality Act (8 U.S.C.*
8 *1182(a)(3)(H)) and found to be removable pursuant*
9 *to section 237(a)(4)(B) of the Immigration and Na-*
10 *tionality Act (8 U.S.C. 1227(a)(4)(B)).*
