A BILL

To require that the Amtrak Board of Directors comply with the open meetings requirements of section 552b of title 5, United States Code, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Amtrak Transparency*
5 *and Accountability for Passengers and Taxpayers Act”.*

6 **SEC. 2. OPEN MEETINGS.**

7 *Section 24301(e) of title 49, United States Code, is*
8 *amended—*

9 *(1) by striking “Section 552 of title 5, this part”*
10 *and inserting the following:*

11 *“(1) IN GENERAL.—Except as provided in para-*
12 *graph (3), section 552 of title 5 and the open meetings*
13 *requirements of section 552b of such title, this part”;*

14 *(2) in the second sentence by striking “Section*
15 *552 of title 5, United States Code, applies” and in-*
16 *serting the following:*

17 *“(2) TIMING OF APPLICATION.—Except as pro-*
18 *vided in paragraph (3), sections 552 and 552b of title*
19 *5 apply”;* and

20 *(3) by adding at the end the following:*

21 *“(3) SCOPE OF APPLICATION.—*

22 *“(A) INFORMATION.—The requirements of*
23 *the second sentence of section 552b(b) of title 5*
24 *shall not apply to any portion of an Amtrak*
25 *meeting and subsections (d) and (e) of section*

1 552b of title 5 shall not apply to any informa-
2 tion pertaining to any portion of an Amtrak
3 meeting otherwise required by section 552b of
4 title 5 to be disclosed to the public in any case
5 in which Amtrak properly determines that such
6 portion or portions of the meeting or the disclo-
7 sure of such information is likely to involve—

8 “(i) contract negotiations, including
9 negotiations for procurements and agree-
10 ments that may result in a contract, the
11 disclosure of which would imperil or com-
12 promise the competitive position of Amtrak;

13 “(ii) collective bargaining agreements
14 or any terms and conditions that are pro-
15 posed for inclusion in any collective bar-
16 gaining agreement, including the negotia-
17 tion of terms and conditions with employees
18 or representatives of employees of Amtrak;

19 “(iii) with respect to any individual
20 who is a prospective officer, employee, or
21 contractor or an officer, employee, or con-
22 tractor employed or appointed by Amtrak,
23 matters involving the employment, appoint-
24 ment, termination of employment, terms
25 and conditions of employment, evaluation of

1 *the performance of, promotion or dis-*
2 *ciplining of any such individual, unless all*
3 *such individuals whose rights could be ad-*
4 *versely affected request in writing that the*
5 *matter or matters be discussed at a public*
6 *meeting; or*

7 *“(iv) confidential commercial informa-*
8 *tion.*

9 *“(B) ADDITIONAL APPLICATION.—In addi-*
10 *tion to the information described in subpara-*
11 *graph (B), the information described in section*
12 *552b(c) shall apply to Amtrak meetings.*

13 *“(4) RULE OF CONSTRUCTION.—Nothing in this*
14 *subsection shall be construed to—*

15 *“(A) require Amtrak to disclose information*
16 *that could put the safety of Amtrak customers or*
17 *employees at risk; or*

18 *“(B) prevent Amtrak from taking any ac-*
19 *tion otherwise necessary to—*

20 *“(i) comply with law;*

21 *“(ii) honor existing contracts or legally*
22 *binding agreements; or*

23 *“(iii) carry out normal business activi-*
24 *ties consistent with the statutory mission*
25 *and goals of Amtrak.”.*
