## A BILL

To prohibit the President and the Secretary of Health and Human Services from declaring certain emergencies or disasters for the purpose of imposing gun control.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting the Right  
5 to Keep and Bear Arms Act of 2025”.

1 **SEC. 2. LIMITATION ON DECLARATIONS BY PRESIDENT.**

2       The President (or any designee thereof) shall not, for  
3 the purpose of imposing gun control, declare an emergency  
4 pursuant to the National Emergencies Act (50 U.S.C.  
5 1601 et seq.) or an emergency or major disaster pursuant  
6 to the Robert T. Stafford Disaster Relief and Emergency  
7 Assistance Act (42 U.S.C. 5121 et seq.).

8 **SEC. 3. LIMITATION ON DECLARATIONS BY HHS.**

9       The Secretary of Health and Human Services shall  
10 not, for the purpose of imposing gun control, declare a  
11 public health emergency pursuant to section 319 of the  
12 Public Health Service Act (42 U.S.C. 247d).

13 **SEC. 4. FIREARMS POLICIES.**

14       Section 706(a) of the Robert T. Stafford Disaster Re-  
15 lief and Emergency Assistance Act (42 U.S.C. 5207(a))  
16 is amended—

17           (1) in paragraph (3), by striking “; or” and in-  
18 serting a semicolon;

19           (2) in paragraph (4), by striking the period and  
20 inserting a semicolon; and

21           (3) by adding at the end the following:

22           “(5) prohibit the possession, manufacture, sale,  
23 or transfer of arms, as protected by the Second  
24 Amendment to the Constitution of the United  
25 States;

1           “(6) prohibit the possession, manufacture, sale,  
2 or transfer of ammunition;

3           “(7) prohibit the possession, manufacture, sale,  
4 or transfer of ammunition feeding devices; or

5           “(8) prohibit the possession, manufacture, sale,  
6 or transfer of firearms accessories.”.
