# H. R. 2201

## AN ACT

To amend title 38, United States Code, to improve claims, made under laws administered by the Secretary of Veterans Affairs, regarding military sexual trauma, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Improving VA Train-  
3 ing for Military Sexual Trauma Claims Act”.

4 **SEC. 2. IMPROVEMENT OF CLAIMS BASED ON MILITARY**  
5 **SEXUAL TRAUMA UNDER LAWS ADMINIS-**  
6 **TERED BY THE SECRETARY OF VETERANS AF-**  
7 **FAIRS.**

8 (a) TRAINING FOR EMPLOYEES WHO PROCESS SUCH  
9 CLAIMS.—

10 (1) IN GENERAL.—Subsection (c) of section  
11 1166 of title 38, United States Code, is amended—

12 (A) in paragraph (1), by striking “mem-  
13 bers of teams established under subsection (a)  
14 are trained” and inserting “each employee of  
15 the Department who processes such a claim,  
16 communicates with a claimant regarding evi-  
17 dence supporting such a claim, or decides such  
18 a claim, receives annual sensitivity training and  
19 training”; and

20 (B) by adding at the end the following new  
21 paragraphs:

22 “(4) The Secretary shall ensure that training received  
23 by an employee under this subsection is appropriate for  
24 how much experience the employee has with such claims.

25 “(5) The Secretary shall update training under this  
26 subsection not less than once annually.”.

1           (2) REPORT.—Not later than 90 days after the  
2           date of the enactment of this Act, the Secretary of  
3           Veterans Affairs shall submit to the Committees on  
4           Veterans’ Affairs of the Senate and House of Rep-  
5           resentatives a report regarding—

6                   (A) training provided under such sub-  
7                   section before such date; and

8                   (B) plans of the Secretary to carry out the  
9                   amendments made by paragraph (1).

10          (b) EXPANSION OF DUTY TO ASSIST IN OBTAINING  
11          RECORDS FOR A COMPENSATION CLAIM.—Section  
12          5103A(c) of title 38, United States Code, is amended—

13                   (1) by redesignating paragraph (2) as para-  
14                   graph (3); and

15                   (2) by inserting, after paragraph (1), the fol-  
16                   lowing new paragraph (2):

17           “(2) In the case of a claim under section 1166 of  
18           this title, the assistance provided by the Secretary under  
19           this section shall include obtaining—

20                   “(A) the service personnel record of the claim-  
21                   ant; and

22                   “(B) the service medical record of the claim-  
23                   ant.”.

24          (c) SENSITIVITY TRAINING FOR CERTAIN CON-  
25          TRACTED HEALTH CARE PROFESSIONALS: REPORT; IM-

1 PROVEMENTS.—Not later than 90 days after the date of  
2 the enactment of this Act, the Secretary of Veterans Af-  
3 fairs shall submit to the Committees on Veterans' Affairs  
4 of the Senate and House of Representatives a report on—

5           (1) sensitivity training required for health care  
6           professionals and individuals who communicate with  
7           veterans to schedule examinations, contracted under  
8           section 504 of the Veterans' Benefits Improvements  
9           Act of 1996 (Public Law 104–275; 38 U.S.C. 5101  
10          note), to perform examinations of veterans who  
11          make claims under section 1166 of title 38, United  
12          States Code; and

13           (2) the plan of the Secretary to—

14                   (A) improve such sensitivity training; and

15                   (B) ensure that a veteran who makes such  
16           a claim is not retraumatized during such an ex-  
17           amination by such a contracted health care pro-  
18           fessional.
