A BILL

To amend title 38, United States Code, to improve claims, made under laws administered by the Secretary of Veterans Affairs, regarding military sexual trauma, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Improving VA Training*
5 *for Military Sexual Trauma Claims Act”.*

6 **SEC. 2. IMPROVEMENT OF CLAIMS BASED ON MILITARY**
7 **SEXUAL TRAUMA UNDER LAWS ADMINIS-**
8 **TERED BY THE SECRETARY OF VETERANS AF-**
9 **FAIRS.**

10 *(a) TRAINING FOR EMPLOYEES WHO PROCESS SUCH*
11 *CLAIMS.—*

12 *(1) IN GENERAL.—Subsection (c) of section 1166*
13 *of title 38, United States Code, is amended—*

14 *(A) in paragraph (1), by striking “members*
15 *of teams established under subsection (a) are*
16 *trained” and inserting “each employee of the De-*
17 *partment who processes such a claim, commu-*
18 *nicates with a claimant regarding evidence sup-*
19 *porting such a claim, or decides such a claim,*
20 *receives annual sensitivity training and train-*
21 *ing”; and*

22 *(B) by adding at the end the following new*
23 *paragraphs:*

1 “(4) *The Secretary shall ensure that training received*
2 *by an employee under this subsection is appropriate for how*
3 *much experience the employee has with such claims.*

4 “(5) *The Secretary shall update training under this*
5 *subsection not less than once annually.*”.

6 (2) *REPORT.—Not later than 90 days after the*
7 *date of the enactment of this Act, the Secretary of Vet-*
8 *erans Affairs shall submit to the Committees on Vet-*
9 *erans’ Affairs of the Senate and House of Representa-*
10 *tives a report regarding—*

11 (A) *training provided under such subsection*
12 *before such date; and*

13 (B) *plans of the Secretary to carry out the*
14 *amendments made by paragraph (1).*

15 (b) *EXPANSION OF DUTY TO ASSIST IN OBTAINING*
16 *RECORDS FOR A COMPENSATION CLAIM.—Section 5103A(c)*
17 *of title 38, United States Code, is amended—*

18 (1) *by redesignating paragraph (2) as para-*
19 *graph (3); and*

20 (2) *by inserting, after paragraph (1), the fol-*
21 *lowing new paragraph (2):*

22 “(2) *In the case of a claim under section 1166 of this*
23 *title, the assistance provided by the Secretary under this*
24 *section shall include obtaining—*

1 “(A) *the service personnel record of the claimant;*
2 *and*

3 “(B) *the service medical record of the claimant.*”.

4 *(c) SENSITIVITY TRAINING FOR CERTAIN CONTRACTED*
5 *HEALTH CARE PROFESSIONALS: REPORT; IMPROVE-*
6 *MENTS.—Not later than 90 days after the date of the enact-*
7 *ment of this Act, the Secretary of Veterans Affairs shall sub-*
8 *mit to the Committees on Veterans’ Affairs of the Senate*
9 *and House of Representatives a report on—*

10 *(1) sensitivity training required for health care*
11 *professionals and individuals who communicate with*
12 *veterans to schedule examinations, contracted under*
13 *section 504 of the Veterans’ Benefits Improvements*
14 *Act of 1996 (Public Law 104–275; 38 U.S.C. 5101*
15 *note), to perform examinations of veterans who make*
16 *claims under section 1166 of title 38, United States*
17 *Code; and*

18 *(2) the plan of the Secretary to—*

19 *(A) improve such sensitivity training; and*

20 *(B) ensure that a veteran who makes such*
21 *a claim is not retraumatized during such an ex-*
22 *amination by such a contracted health care pro-*
23 *fessional.*
