Mr. PFLUGER (for himself and Mr. EDWARDS) introduced the following bill;
which was referred to the Committee on Education and Workforce

A BILL

To make certain individuals ineligible to receive any Federal
financial aid under title IV of the Higher Education
Act of 1965.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Freeze Aid For Stu-
5 dent Assaulters Act of 2025” or the “FAFSA Act of
6 2025”.

7 **SEC. 2. IN GENERAL.**

8 (a) **TERMINATION OF ELIGIBILITY FOR TITLE IV AS-**
9 **SISTANCE.**—Beginning with the first award year that be-
10 gins after the date of the enactment of the Freeze Aid

1 For Student Assaulters Act of 2025, an individual shall
2 not be eligible to receive any grant, loan (other than a
3 loan described in subsection (b)), or work assistance under
4 title IV of the Higher Education Act of 1965 (20 U.S.C.
5 1070 et seq.) and shall repay, in accordance with sub-
6 section (b), the sum of the amounts of any grant received
7 under such title, if the individual has been convicted of
8 a criminal offense—

9 (1) of assault against a police officer; or

10 (2) of rioting, the elements of which may in-
11 clude—

12 (A) inciting a riot;

13 (B) organizing, promoting, encouraging,
14 participating in, or carrying on a riot;

15 (C) committing any act of violence in fur-
16 therance of a riot; or

17 (D) aiding or abetting any person in incit-
18 ing or participating in or carrying on a riot or
19 committing any act of violence in furtherance of
20 a riot.

21 (b) CONVERSION OF GRANTS TO LOANS.—

22 (1) IN GENERAL.—If an individual who is sub-
23 ject to the termination of eligibility described in sub-
24 section (a) has received any grants under title IV of
25 the Higher Education Act of 1965 (20 U.S.C. 1070

1 et seq.) for a program of study in which the indi-
2 vidual is enrolled as of the date on which the crimi-
3 nal offense occurred, such grant shall be treated as
4 a Federal Direct Unsubsidized Stafford Loan under
5 part D of such title, and shall be subject to repay-
6 ment, together with interest thereon accruing from
7 the date of the grant award.

8 (2) NO REPAYMENT ASSISTANCE.—Such loans
9 may not be eligible for any loan forgiveness, can-
10 cellation, discharge, or reduction programs under the
11 Higher Education Act of 1965 (20 U.S.C. 1001 et
12 seq.), any other provision of law, or any administra-
13 tive action or program.
