A BILL

To take certain Federal land in the State of California into trust for the benefit of the Shingle Springs Band of Miwok Indians, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Shingle Springs Band*
 5 *of Miwok Indians Land Transfer Act of 2025”.*

6 **SEC. 2. REVOCATION OF PUBLIC LAND ORDER; LANDS TO**
 7 **BE TAKEN INTO TRUST.**

8 *(a) REVOCATION OF PUBLIC LAND ORDER.—Notwith-*
 9 *standing any other provision of law—*

10 *(1) Public Land Order 3309 (Sacramento*
 11 *071209), dated January 17, 1964 (29 Fed. Reg. 609),*
 12 *is revoked; and*

13 *(2) jurisdiction over the land described in the*
 14 *public land order referred to in paragraph (1) is*
 15 *transferred to the Secretary.*

16 *(b) TRUST TRANSFER.—Not later than 180 days after*
 17 *the date of the enactment of this Act, subject to valid exist-*
 18 *ing rights, the Secretary shall place the following land into*
 19 *trust for the benefit of the Tribe:*

20 *(1) The approximately 80 acres of land generally*
 21 *depicted as “BLM Land–Proposed Transfer into*
 22 *Trust” on the Map.*

23 *(2) The approximately 185 acres of land gen-*
 24 *erally depicted as “Indian Creek Ranch–Proposed*
 25 *Transfer into Trust Land Status” on the Map.*

1 (c) *REVIEW; SURVEY.*—

2 (1) *REVIEW.*—*Before the deadline described in*
 3 *subsection (b), the Secretary shall conduct a review of*
 4 *the land described in that subsection to determine if*
 5 *a survey of the land is required.*

6 (2) *SURVEY.*—

7 (A) *IN GENERAL.*—*If the Secretary deter-*
 8 *mines that a survey is required under paragraph*
 9 *(1) after conducting the review required under*
 10 *that paragraph, the Secretary—*

11 (i) *shall perform a survey of the land*
 12 *taken into trust under subsection (b); and*

13 (ii) *may make minor corrections to the*
 14 *survey and legal land description of the*
 15 *land described in that subsection as the Sec-*
 16 *retary determines to be necessary to correct*
 17 *clerical, typographical, and surveying er-*
 18 *rors.*

19 (B) *AVAILABILITY.*—*A survey conducted*
 20 *under subparagraph (A) shall be kept on file and*
 21 *available for public inspection in the appro-*
 22 *priate office of the Bureau of Indian Affairs.*

23 (d) *LANDS PART OF RESERVATION; ADMINISTRA-*
 24 *TION.*—*The land taken into trust under subsection (b)—*

1 (1) *is hereby declared to be part of the Reserva-*
2 *tion; and*

3 (2) *shall be administered by the Secretary in ac-*
4 *cordance with the laws and regulations generally ap-*
5 *plicable to property held in trust by the United States*
6 *for an Indian Tribe.*

7 (e) *GAMING PROHIBITED.*—*Land taken into trust*
8 *under subsection (b) shall not be used for any class II gam-*
9 *ing or class III gaming under the Indian Gaming Regu-*
10 *latory Act (25 U.S.C. 2701 et seq.) (as those terms are de-*
11 *finied in section 4 of that Act (25 U.S.C. 2703)).*

12 (f) *DEFINITIONS.*—*In this section:*

13 (1) *MAP.*—*The term “Map” means the map pre-*
14 *pared by the Bureau of Land Management titled*
15 *“Proposed Bureau of Land Management Land Trans-*
16 *fer to Shingle Springs Rancheria” and dated May 2,*
17 *2025.*

18 (2) *RESERVATION.*—*The term “Reservation”*
19 *means the reservation of the Tribe.*

20 (3) *SECRETARY.*—*The term “Secretary” means*
21 *the Secretary of the Interior.*

22 (4) *TRIBE.*—*The term “Tribe” means the Shin-*
23 *gle Springs Band of Miwok Indians, Shingle Springs*
24 *Rancheria (Verona Tract), California.*
