A BILL

To require the Secretary of Veterans Affairs to award grants
to nonprofit organizations to assist such organizations
in carrying out programs to provide service dogs to eligi-
ble veterans, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Service Dogs Assisting*
5 *Veterans Act” or the “SAVES Act”.*

6 **SEC. 2. DEPARTMENT OF VETERANS AFFAIRS PILOT PRO-**
7 **GRAM TO AWARD GRANTS FOR THE PROVI-**
8 **SION OF SERVICE DOGS TO VETERANS.**

9 *(a) IN GENERAL.—Not later than 24 months after the*
10 *date of the enactment of this Act, the Secretary of Veterans*
11 *Affairs shall establish a pilot program under which the Sec-*
12 *retary shall award grants, on a competitive basis, to non-*
13 *profit entities to provide service dogs to eligible veterans.*

14 *(b) APPLICATIONS.—*

15 *(1) IN GENERAL.—To be eligible to receive a*
16 *grant under this section, a nonprofit entity shall sub-*
17 *mit an application to the Secretary at such time, in*
18 *such manner, and containing such commitments and*
19 *information as the Secretary may require.*

20 *(2) ELEMENTS.—An application submitted*
21 *under paragraph (1) shall include the following:*

22 *(A) A proposal for the provision of service*
23 *dogs to eligible veterans, including how the non-*
24 *profit entity will communicate with the Sec-*
25 *retary to ensure that the use of the grant funds*

1 *results in an increased number of eligible vet-*
2 *erans who are provided with service dogs.*

3 *(B) A description of the following services*
4 *or commitments to be provided by the nonprofit*
5 *entity:*

6 *(i) The training that will be provided*
7 *to eligible veterans who receive service dogs*
8 *under the pilot program.*

9 *(ii) The training of dogs that will serve*
10 *as service dogs provided to eligible veterans*
11 *under the program.*

12 *(iii) Any support or services other than*
13 *training under clauses (i) and (ii) that will*
14 *be provided for such dogs and eligible vet-*
15 *erans.*

16 *(iv) The plan for publicizing the avail-*
17 *ability of such service dogs through a mar-*
18 *keting campaign that targets eligible vet-*
19 *erans.*

20 *(v) The commitment to humane treat-*
21 *ment standards for service dogs.*

22 *(C) Documentation that demonstrates that*
23 *the nonprofit entity has experience in training*
24 *dogs as service dogs.*

1 (D) *The demonstrated experience of the non-*
2 *profit entity in training service dogs in compli-*
3 *ance with the requirements of the Americans*
4 *with Disabilities Act of 1990 (42 U.S.C. 12101*
5 *et seq.).*

6 (c) *AGREEMENT REQUIRED.—If the Secretary ap-*
7 *proves an application submitted by a nonprofit entity*
8 *under subsection (b)(1), the Secretary shall require the enti-*
9 *ty, as a condition of the receipt of a grant under the pilot*
10 *program to enter into an agreement under which the entity*
11 *agrees to—*

12 (1) *notify each veteran who receives a service dog*
13 *provided using grant funds that the service dog is*
14 *being paid for, in whole or in part, by the Depart-*
15 *ment of Veterans Affairs;*

16 (2) *inform each such veteran of the benefits and*
17 *services available from the Secretary for the veteran*
18 *and the service dog;*

19 (3) *not charge a fee to a veteran receiving a serv-*
20 *ice dog provided using grant funds; and*

21 (4) *adhere to such other terms, conditions, and*
22 *limitations as the Secretary determines appropriate.*

23 (d) *AMOUNT OF GRANTS.—The Secretary shall make*
24 *a grant in an amount that does not exceed \$2,000,000 to*
25 *each entity that enters into an agreement with the Secretary*

1 *under subsection (c). The Secretary shall establish intervals*
2 *of payment for the administration of each such grant.*

3 *(e) USE OF FUNDS.—*

4 *(1) IN GENERAL.—A recipient of a grant under*
5 *this section shall use the grant to plan, develop, im-*
6 *plement, and manage one or more programs that pro-*
7 *vide service dogs to eligible veterans.*

8 *(2) LIMITATIONS.—The Secretary may estab-*
9 *lish—*

10 *(A) a maximum amount that can be used*
11 *by a grant recipient to cover administrative ex-*
12 *penses for each grant awarded under this section;*
13 *and*

14 *(B) other conditions or limitations on the*
15 *use of grant amounts under this section.*

16 *(f) VETERINARY INSURANCE.—*

17 *(1) IN GENERAL.—Except as provided in para-*
18 *graph (3), the Secretary may provide to each veteran*
19 *who receives a service dog through a grant under this*
20 *section a commercially available veterinary insurance*
21 *policy for the service dog.*

22 *(2) CONTINUATION.—If the Secretary provides a*
23 *veterinary insurance policy to a veteran under para-*
24 *graph (1), the Secretary shall continue to provide the*
25 *policy to the veteran without regard to the continu-*

1 *ation or termination of the pilot program, except as*
2 *provided in paragraph (3).*

3 (3) *DISCONTINUATION.*—*The Secretary shall dis-*
4 *continue the provision of a veterinary insurance pol-*
5 *icy under paragraph (1) if the Secretary determines*
6 *doing so would be in the best interest of the veteran,*
7 *the service dog, or the Federal Government.*

8 (g) *TRAINING AND TECHNICAL ASSISTANCE.*—*The Sec-*
9 *retary may provide training and technical assistance re-*
10 *lated to grant application and administration to appli-*
11 *cants for and recipients of grants under this section.*

12 (h) *OVERSIGHT AND MONITORING.*—

13 (1) *IN GENERAL.*—*The Secretary—*

14 (A) *shall establish such oversight and moni-*
15 *toring requirements as the Secretary determines*
16 *appropriate to ensure that grant amounts*
17 *awarded under this section are used appro-*
18 *priately; and*

19 (B) *may take such actions as the Secretary*
20 *determines necessary to address any issues iden-*
21 *tified through the enforcement of such require-*
22 *ments.*

23 (2) *REPORTS AND ANSWERS.*—*The Secretary*
24 *may require each recipient of a grant under this sec-*
25 *tion to provide, in such form as may be prescribed by*

1 *the Secretary, such reports or answers in writing to*
2 *specific questions, surveys, or questionnaires as the*
3 *Secretary determines necessary to carry out the pilot*
4 *program.*

5 *(i) DEFINITIONS.—In this section:*

6 *(1) The term “eligible veteran” means a veteran*
7 *who—*

8 *(A) is enrolled in the system of annual pa-*
9 *tient enrollment of the Department of Veterans*
10 *Affairs established and operated under section*
11 *1705(a) of title 38, United States Code, or is oth-*
12 *erwise entitled to receive such care and services*
13 *under subsection (c)(2) of such section;*

14 *(B) has been prescribed a service dog by the*
15 *Secretary; and*

16 *(C) has one or more covered conditions.*

17 *(2) The term “covered condition” means any of*
18 *the following disabilities, conditions, or diagnoses for*
19 *which the Secretary determines, based upon medical*
20 *judgment, that it is optimal for the veteran to man-*
21 *age the disability, condition, or diagnosis and live*
22 *independently through the assistance of a trained*
23 *service dog:*

24 *(A) Blindness or visual impairment.*

1 (B) *Loss of use of a limb, paralysis, or*
2 *other significant mobility issue, including men-*
3 *tal health mobility.*

4 (C) *Loss of hearing.*

5 (D) *Post-traumatic stress disorder.*

6 (E) *Traumatic brain injury.*

7 (F) *Any other disability, condition, or diag-*
8 *nosis for which the Secretary determines, based*
9 *on medical judgment, that it is optimal for the*
10 *veteran to manage the disability, condition, or*
11 *diagnosis, and live independently through the as-*
12 *sistance of a service dog.*

13 (3) *The term “service dog” means a dog that is*
14 *individually trained to do work or perform tasks for*
15 *the benefit of an individual with a disability, includ-*
16 *ing a physical, sensory, psychiatric, intellectual, or*
17 *other mental disability.*

18 (j) *AUTHORIZATION OF APPROPRIATIONS.—There is*
19 *authorized to be appropriated to carry out this section*
20 *\$10,000,000 for each of fiscal years 2027 through 2031.*

21 (k) *TERMINATION.—The authority to carry out a pilot*
22 *program under this section shall terminate on September*
23 *30, 2031.*

1 **SEC. 3. EXTENSION OF CERTAIN LIMITS ON PAYMENTS OF**
2 **PENSION.**
