A BILL

To require the Secretary of Homeland Security to publish on a monthly basis the number of special interest aliens encountered attempting to unlawfully enter the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Special Interest Alien*
5 *Reporting Act of 2025”.*

6 **SEC. 2. PUBLICATION BY THE DEPARTMENT OF HOMELAND**
7 **SECURITY OF THE NUMBER OF SPECIAL IN-**
8 **TEREST ALIENS ENCOUNTERED.**

9 *(a) IN GENERAL.—Not later than the seventh day of*
10 *each month beginning with the first full month that begins*
11 *after the date of the enactment of this Act, the Secretary*
12 *of Homeland Security shall publish on a publicly available*
13 *webpage of the Department of Homeland Security and sub-*
14 *mit to the Committee on Homeland Security of the House*
15 *of Representatives and the Committee on Homeland Secu-*
16 *rity and Governmental Affairs of the Senate a report on*
17 *the total number, and an identification of the nationalities*
18 *or countries of last habitual residence, of special interest*
19 *aliens encountered by the Department during the imme-*
20 *diately preceding month. Each such report shall also in-*
21 *clude the following:*

22 *(1) Such number disaggregated by geographic re-*
23 *gions of such encounters.*

24 *(2) Specifications relating to whether such en-*
25 *counters were made at land, air, or sea ports of entry,*

1 *between ports of entry, or in the interior of the*
2 *United States.*

3 (3) *Identification of any such nationalities or*
4 *countries of last habitual residence that are covered*
5 *nations.*

6 (b) *INCLUSION.—The first report required under sub-*
7 *section (a) shall also include the matters described in such*
8 *subsection for the time period from January 20, 2021,*
9 *through January 19, 2025.*

10 (c) *DEFINITIONS.—In this section:*

11 (1) *ALIEN.—The term “alien” has the meaning*
12 *given such term in section 101 of the Immigration*
13 *and Nationality Act (8 U.S.C. 1101).*

14 (2) *COVERED NATION.—The term “covered na-*
15 *tion” has the meaning given such term in section*
16 *4872(d)(2) of title 10, United States Code.*

17 (3) *SPECIAL INTEREST ALIEN.—The term “spe-*
18 *cial interest alien” means an alien who, based on an*
19 *analysis of travel patterns, potentially poses a na-*
20 *tional security risk to the United States or its inter-*
21 *ests.*
