A BILL

To direct the Secretary of the Interior to reissue a final rule relating to removing the Greater Yellowstone Ecosystem population of grizzly bears from the Federal list of endangered and threatened wildlife, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Grizzly Bear State Man-*
5 *agement Act”.*

6 **SEC. 2. REISSUANCE OF FINAL RULE RELATING TO GREAT-**
7 **ER YELLOWSTONE ECOSYSTEM POPULATION**
8 **OF GRIZZLY BEARS.**

9 (a) *IN GENERAL.*—*Not later than 180 days after the*
10 *date of the enactment of this Act, the Secretary of the Inte-*
11 *rior shall reissue the final rule entitled “Endangered and*
12 *Threatened Wildlife and Plants; Removing the Greater Yel-*
13 *lowstone Ecosystem Population of Grizzly Bears From the*
14 *Federal List of Endangered and Threatened Wildlife” (82*
15 *Fed. Reg. 30502 (June 30, 2017)) without regard to any*
16 *other provision of law that applies to the issuance of that*
17 *final rule.*

18 (b) *NO JUDICIAL REVIEW.*—*The reissuance of the final*
19 *rule described in subsection (a) (including this section)*
20 *shall not be subject to judicial review.*
