Mr. MOORE of North Carolina (for himself and Mr. FIELDS) introduced the following bill; which was referred to the Committee on Financial Services

A BILL

To require the Secretary of Housing and Urban Development to submit to the Congress a report that describes the methodology used to allocate amounts appropriated in covered provisions for the Community Development Block Grant Disaster Recovery Program and the Community Development Block Grant Mitigation Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Disaster Relief Trans-
5 parency Act”.

1 **SEC. 2. HUD REPORT.**

2 (a) IN GENERAL.—The Secretary of Housing and
3 Urban Development (in this section referred to as the
4 “Secretary”), after consultation with the Comptroller
5 General of the United States, shall submit to the Financial
6 Services, Oversight and Reform, and Transportation and
7 Infrastructure Committees of the House of Representa-
8 tives and Banking Committee of the Senate a report
9 that—

10 (1) describes and explains the methodology used
11 by the Department of Housing and Urban Develop-
12 ment to allocate, to States, Tribes, Territories, and
13 local governments, any amounts appropriated for the
14 Community Development Block Grant Disaster Re-
15 covery Program and the Community Development
16 Block Grant Mitigation Program;

17 (2) addresses why such methodology may result
18 in allocations to States, Tribes, Territories, and local
19 governments differing between appropriations; and

20 (3) provides legislative and administrative rec-
21 ommendations for improving the consistency and
22 timeliness of the allocation of amounts appropriated
23 for the Community Development Block Grant Dis-
24 aster Recovery Program and the Community Devel-
25 opment Block Grant Mitigation Program.

26 (b) FIRST REPORT.—The Secretary shall—

1 (1) submit the first report described in sub-
2 section (a) not later than 90 days after the date of
3 the enactment of this Act; and

4 (2) examine the amounts appropriated for fiscal
5 years 2025 and 2024 in such report.

6 (c) SUBSEQUENT REPORTS.—After the submission of
7 the first report described in subsection (b), the Secretary
8 shall—

9 (1) beginning in fiscal year 2026, submit the
10 report described in subsection (a) not later than the
11 final day of each fiscal year; and

12 (2) examine the amounts appropriated for the
13 fiscal year.
