## A BILL

To direct the United States Postal Service to designate single, unique ZIP Codes for certain communities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SINGLE, UNIQUE ZIP CODES FOR CERTAIN**  
4 **COMMUNITIES.**

5 Not later than 270 days after the date of the enact-  
6 ment of this Act, the United States Postal Service shall

1 designate a single, unique ZIP Code for each of the fol-
