A BILL

To amend the Internal Revenue Code of 1986 to allow married couples to apply the student loan interest deduction limitation separately to each spouse, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Student Loan Mar-
5 riage Penalty Elimination Act of 2025”.

1 **SEC. 2. STUDENT LOAN INTEREST DEDUCTION LIMITATION**
2 **APPLIED SEPARATELY TO EACH SPOUSE.**

3 (a) IN GENERAL.—Section 221(b)(1) of the Internal
4 Revenue Code of 1986 is amended to read as follows:

5 “(1) IN GENERAL.—The interest taken into ac-
6 count with respect to a taxpayer for a taxable year
7 under subsection (a) for indebtedness incurred by an
8 individual shall not exceed \$2,500.”.

9 (b) CONFORMING AMENDMENTS.—Section 221 of
10 such Code is amended—

11 (1) in subsection (b), by striking the heading
12 and inserting “DOLLAR LIMITATIONS”, and

13 (2) by amending subsection (e) to read as fol-
14 lows:

15 “(e) DENIAL OF DOUBLE BENEFIT.—No deduction
16 shall be allowed under this section for any amount for
17 which a deduction is allowable under any other provision
18 of this chapter.”.

19 (c) EFFECTIVE DATE.—The amendments made by
20 this section shall apply to taxable years beginning after
21 December 31, 2024.
