A BILL

To modify the program of grants to support high-quality
charter schools.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Empower Charter School*
5 *Educators to Lead Act”.*

6 **SEC. 2. GRANTS TO SUPPORT HIGH-QUALITY CHARTER**
7 **SCHOOLS.**

8 *Section 4303 of the Elementary and Secondary Edu-*
9 *cation Act of 1965 (20 U.S.C. 7221b) is amended—*

10 *(1) in subsection (b)—*

11 *(A) in paragraph (1)(C), by striking “and”*
12 *after the semicolon; and*

13 *(B) by striking paragraph (2) and inserting*
14 *the following:*

15 *“(2)(A) provide technical assistance to eligible*
16 *applicants and authorized public chartering agencies*
17 *in carrying out the activities described in paragraph*
18 *(1);*

19 *“(B) work with authorized public chartering*
20 *agencies in the State to improve authorizing quality,*
21 *including developing capacity for, and conducting,*
22 *fiscal oversight and auditing of charter schools; and*

23 *“(C) at the State entity’s discretion—*

24 *“(i) fund a revolving loan fund or similar*
25 *mechanisms for the expenses of eligible appli-*

1 *cants under subsection (h) prior to the receipt of*
2 *subgrant funds under paragraph (1); and*

3 *“(i) provide assistance to eligible appli-*
4 *cants in locating and accessing a facility; and*

5 *“(3) provide pre-charter planning subgrants (in*
6 *amounts of no more than \$100,000 per subgrantee) to*
7 *charter school developers that—*

8 *“(A) intend to submit an application—*

9 *“(i) to an authorized public chartering*
10 *agency to operate a charter school; or*

11 *“(ii) to nonprofit or public entities for*
12 *the provision of financial support to such*
13 *developers;*

14 *“(B) are led by educators who—*

15 *“(i) have not less than 54 months of*
16 *school-based experience (which may include*
17 *experience in teaching in or administering*
18 *after school or summer school programs);*
19 *and*

20 *“(ii) have demonstrated leadership*
21 *competencies and success with students, as*
22 *determined by the State entity; and*

23 *“(C) have successfully completed the devel-*
24 *opment of an initial plan for opening a charter*
25 *school, as evidenced by a description of the edu-*

1 *cational needs of the community in which the*
2 *proposed charter school will be located and how*
3 *the proposed charter school will be suited to meet*
4 *those needs.”;*

5 (2) *in subsection (c)(1)—*

6 (A) *in subparagraph (A), by striking “90*
7 *percent” and inserting “82 percent”;*

8 (B) *in subparagraph (B)—*

9 (i) *by striking “not less than 7 per-*
10 *cent” and inserting “not more than 10 per-*
11 *cent”;* and

12 (ii) *by striking “and” after the semi-*
13 *colon;*

14 (C) *by redesignating subparagraph (C) as*
15 *subparagraph (D);*

16 (D) *by inserting after subparagraph (B) the*
17 *following:*

18 “(C) *reserve not more than 5 percent of such*
19 *funds to carry out the activities described in sub-*
20 *section (b)(3); and”;*

21 (3) *in subsection (d)(1)(B), by striking “this sec-*
22 *tion” and inserting “subsection (b)(1)”;*

23 (4) *in subsection (e)(2), by striking “this sec-*
24 *tion” and inserting “subsection (b)(1)”;*

25 (5) *in subsection (f)(1)(A)(vi)—*

1 (A) in the matter preceding subclause (I),
2 by inserting “under subsection (b)(1)” after
3 “program”; and

4 (B) in subclause (II), by striking “subgrant
5 funds under this section” and inserting
6 “subgrant funds under subsection (b)(1)”; and

7 (6) in subsection (h), in the matter preceding
8 paragraph (1), by striking “this section” and insert-
9 ing “subsection (b)(1)”.
