A BILL

To amend the Small Business Act for microloan eligibility
for the Commonwealth of the Northern Mariana Islands,

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Northern Mariana Is-*
 5 *lands Small Business Access Act”.*

6 **SEC. 2. INCLUSION OF THE COMMONWEALTH OF THE**
 7 **NORTHERN MARIANA ISLANDS IN THE**
 8 **MICROLOAN PROGRAM.**

9 (a) *IN GENERAL.*—Section 7(m)(7)(B) of the Small
 10 *Business Act (15 U.S.C. 636(m)(7)(B)) is amended—*

11 (1) *by inserting “, the Commonwealth of the*
 12 *Northern Mariana Islands” after “Guam” each place*
 13 *it appears; and*

14 (2) *in clause (i)(I)(bb), by striking “¹/₅₅” and*
 15 *inserting “¹/₅₆”.*

16 (b) **TECHNICAL AMENDMENT.**—Section
 17 *7(m)(11)(C)(ii) of the Small Business Act (15 U.S.C.*
 18 *636(m)(11)(C)(ii)) is amended by striking “rural” and all*
 19 *that follows through the end of the clause and inserting*
 20 *“rural; and”.*
