A BILL

To authorize the President to seek to enter into negotiations with the Kingdom of Denmark to secure the acquisition of Greenland by the United States.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Make Greenland Great
5 Again Act”.

1 **SEC. 2. AUTHORIZATION TO ENTER INTO NEGOTIATIONS**
2 **WITH THE KINGDOM OF DENMARK.**

3 (a) IN GENERAL.—Congress hereby authorizes the
4 President, beginning at 12:01 p.m. Eastern Standard
5 Time on January 20, 2025, to seek to enter into negotia-
6 tions with the Kingdom of Denmark to secure the acquisi-
7 tion of Greenland by the United States.

8 (b) TRANSMISSION OF AGREEMENT.—Not later than
9 5 calendar days after reaching an agreement with the
10 Kingdom of Denmark relating to the acquisition of Green-
11 land by the United States, the President shall transmit
12 to the appropriate congressional committees the agree-
13 ment, including all related materials and annexes.

14 (c) PERIOD OF REVIEW BY CONGRESS OF AGREE-
15 MENT.—

16 (1) IN GENERAL.—The period for congressional
17 review for any agreement described in subsection (a)
18 shall be 60 calendar days from the date on which
19 the President transmits to the appropriate Congres-
20 sional committees the agreement for the acquisition
21 of Greenland from the Kingdom of Denmark.

22 (2) EFFECTIVE DATE.—If no joint resolution of
23 disapproval is enacted by Congress within the 60-
24 calendar day period, the agreement described in sub-
25 section (a) shall be in effect and take the full force
26 of law.

1 (d) APPROPRIATE CONGRESSIONAL COMMITTEES

2 DEFINED.—In this section, the term “appropriate con-

3 gressional committees” means—

4 (1) the Committee on Foreign Affairs of the

5 House of Representatives; and

6 (2) the Committee on Foreign Relations of the

7 Senate.
