A BILL

To amend the Higher Education Act of 1965 to reinstate the authority of the Secretary of Education to make Federal Direct Stafford Loans to graduate and professional students.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting Our Stu-
5 dents by Terminating Graduate Rates that Add to Debt
6 Act” or the “POST GRAD Act”.

1 **SEC. 2. REINSTATEMENT OF AUTHORITY TO MAKE FED-**
2 **ERAL DIRECT STAFFORD LOANS TO GRAD-**
3 **UATE AND PROFESSIONAL STUDENTS.**

4 Section 455(a)(3) of the Higher Education Act of
5 1965 (20 U.S.C. 1087e(a)(3)) is amended—

6 (1) in the paragraph heading, by inserting
7 “TEMPORARY” before “TERMINATION”; and

8 (2) in subparagraph (A), in the matter pre-
9 ceding clause (i), by inserting “, and ending on or
10 before June 30, 2025” after “2012”.

11 **SEC. 3. INAPPLICABILITY OF RULEMAKING REQUIRE-**
12 **MENTS.**

13 The amendments made by this Act shall not be sub-
14 ject to the requirements of section 482(c) or 492 of the
15 Higher Education Act of 1965 (20 U.S.C. 1089(c);
16 1098a).
