A BILL

To direct the Secretary of the Interior to establish the Wildfire Science and Technology Advisory Board, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Wildfire Coordination
5 Act”.

1 **SEC. 2. WILDFIRE SCIENCE AND TECHNOLOGY ADVISORY**
2 **BOARD.**

3 (a) ESTABLISHMENT.—The Secretary of the Interior
4 shall establish a permanent advisory committee to be
5 known as the Wildfire Science and Technology Advisory
6 Board (in this section referred to as the “Board”).

7 (b) DUTIES.—The Board shall—

8 (1) coordinate the operationalization within the
9 Federal Government of wildfire research, including
10 by—

11 (A) identifying avenues for translating
12 wildfire research into practical applications;

13 (B) establishing criteria and frameworks to
14 prioritize wildfire research projects for
15 operationalization;

16 (C) facilitating the transition of prioritized
17 wildfire research into operational projects;

18 (D) connecting and supporting entities in
19 wildfire research and operations;

20 (E) providing feedback to refine and en-
21 hance wildfire research outputs for practical ap-
22 plication; and

23 (F) partnering, as the Board determines
24 appropriate, with private sector and federally-
25 funded research centers to further the work of
26 the Board;

1 (2) encourage wildfire researchers and Federal
2 agencies undertaking wildfire operations to in-
3 clude—

4 (A) relevant disciplines, such as public
5 health, meteorological science, and predictive
6 modeling; and

7 (B) consideration of built and natural fire-
8 prone environments; and

9 (3) disseminate information, including by—

10 (A) establishing mechanisms, such as
11 newsletters and publications, online portals,
12 webinars, and workshops, to disseminate wild-
13 fire research findings, operational best prac-
14 tices, and resources to relevant stakeholders
15 and practitioners; and

16 (B) promoting activities of the Board to
17 ensure visibility and accessibility to stake-
18 holders.

19 (c) MEMBERSHIP.—

20 (1) NUMBER AND APPOINTMENT.—The Board
21 shall be composed of the following members:

22 (A) The Secretary of the Interior (or the
23 designee thereof).

24 (B) The Secretary of Agriculture (or the
25 designee thereof).

1 (C) The Secretary of Commerce (or the
2 designee thereof).

3 (D) The Chief of the Forest Service (or
4 the designee thereof).

5 (E) The Director of the Bureau of Indian
6 Affairs (or the designee thereof).

7 (F) The Director of the Bureau of Land
8 Management (or the designee thereof).

9 (G) The Administrator of the Federal
10 Emergency Management Agency (or the des-
11 ignee thereof, except that such designee may
12 not be the member of the Board serving pursu-
13 ant to subparagraph (H)).

14 (H) The United States Fire Administrator
15 (or the designee thereof).

16 (I) The Director of the United States Fish
17 and Wildlife Service (or the designee thereof).

18 (J) The Administrator of the National
19 Oceanic and Atmospheric Administration (or
20 the designee thereof).

21 (K) The Director of the National Park
22 Service (or the designee thereof).

23 (L) The Director of the National Institute
24 of Standards and Technology (or the designee
25 thereof).

1 (M) The Director of the U.S. Geological
2 Survey (or the designee thereof).

3 (N) The Director of the Office of Science
4 and Technology Policy (or the designee there-
5 of).

6 (O) The Director of the National Science
7 Foundation (or designee thereof).

8 (P) The Administrator of the National
9 Aeronautics and Space Administration (or des-
10 ignedee thereof).

11 (Q) The Director of the Centers for Dis-
12 ease Control and Prevention (or designee there-
13 of).

14 (R) The Administrator of the Environ-
15 mental Protection Agency (or designee thereof).

16 (S) Not more than 18 non-Federal mem-
17 bers, to be appointed by the Secretary of the
18 Interior, as follows:

19 (i) At least 1 representative from each
20 of the following:

21 (I) State government.

22 (II) Local government.

23 (III) Tribal government.

24 (ii) Representatives of fire depart-
25 ments.

1 (iii) Representatives of relevant pri-
2 vate-sector entities, such as codes and
3 standards-setting organizations, prescribed
4 fire associations, and entities with exper-
5 tise in wildfire science and wildfire risk
6 identification, transfer, and mitigation.

7 (iv) Wildfire, forest health, or ecologi-
8 cal restoration researchers.

9 (v) Public health experts.

10 (vi) Meteorological scientists.

11 (vii) Predictive modeling experts.

12 (viii) Such other members as the Sec-
13 retary of the Interior deems appropriate.

14 (2) TERMS.—

15 (A) IN GENERAL.—Each member of the
16 Board serving pursuant to paragraph (1)(S)
17 shall be appointed for a term of 2 years.

18 (B) VACANCIES.—A vacancy on the Board
19 shall be filled in the manner in which the origi-
20 nal appointment was made.

21 (3) PAY AND EXPENSES.—

22 (A) PROHIBITION ON COMPENSATION.—A
23 member of the Board shall serve without com-
24 pensation.

1 (B) TRAVEL EXPENSES.—Each member of
2 the Board shall receive travel expenses, includ-
3 ing per diem in lieu of subsistence, in accord-
4 ance with applicable provisions under sub-
5 chapter I of chapter 57 of title 5, United States
6 Code.

7 (4) CHAIRPERSON.—

8 (A) IN GENERAL.—Except as provided in
9 subparagraph (B), the Chairperson shall rotate
10 annually among the members of the Board
11 serving pursuant to subparagraphs (A), (B),
12 and (C) of paragraph (1), beginning with the
13 member serving pursuant to paragraph (1)(A),
14 followed by the member serving pursuant to
15 paragraph (1)(B).

16 (B) EXCEPTION.—For any term, the mem-
17 bers of the Board may designate a member of
18 the Board to serve as the Chairperson of the
19 Board in lieu of the official (or the designee
20 thereof) who would otherwise serve as the
21 Chairperson pursuant to subparagraph (A).

22 (5) STAFF; TEMPORARY AND INTERMITTENT
23 SERVICES.—

24 (A) STAFF.—The Board may appoint per-
25 sonnel as it considers appropriate.

1 (B) PAY.—The Chairperson of the Board
2 may fix the compensation of the personnel ap-
3 pointed under subparagraph (A) without regard
4 to the provisions of chapter 51 and subchapter
5 III of chapter 53 of title 5, United States Code,
6 relating to classification of positions and Gen-
7 eral Schedule pay rates, except that the rate of
8 pay for such personnel may not exceed the an-
9 nual rate of basic pay prescribed for level V of
10 the Executive Schedule under section 5316 of
11 such title.

12 (C) DETAIL OF FEDERAL EMPLOYEES.—
13 The head of any Federal department or agency
14 may detail any of the personnel of that depart-
15 ment or agency to the Board. A detail under
16 the preceding sentence shall be without reim-
17 bursement and without interruption or loss of
18 civil service status or privilege.

19 (D) PROCUREMENT OF TEMPORARY AND
20 INTERMITTENT SERVICES.—The Chairperson of
21 the Board may procure temporary and intermit-
22 tent services under section 3109(b) of title 5,
23 United States Code, at rates for individuals
24 that do not exceed the daily equivalent of the
25 annual rate of basic pay prescribed for level V

1 of the Executive Schedule under section 5316
2 of that title.

3 (d) REPORT.—

4 (1) IN GENERAL.—Not later than the date that
5 is 2 years after the date of enactment of this Act,
6 the Board shall submit a report to the relevant con-
7 gressional committees, which shall—

8 (A) detail the activities of the Board;

9 (B) discuss progress on transitioning wild-
10 fire research into operations within the Federal
11 Government;

12 (C) discuss barriers to successfully
13 transitioning wildfire research into operations
14 within the Federal Government; and

15 (D) provide recommendations on future
16 wildfire research priorities and operational
17 needs.

18 (2) RELEVANT CONGRESSIONAL COMMIT-
19 TEES.—In this subsection, the term “relevant con-
20 gressional committees” means—

21 (A) the Committees on Agriculture; Nat-
22 ural Resources; Science, Space, and Tech-
23 nology; and Transportation and Infrastructure
24 of the House of Representatives; and

1 (B) the Committees on Agriculture, Nutri-
2 tion, and Forestry; Commerce, Science, and
3 Transportation; Energy and Natural Resources;
4 Environment and Public Works; and Homeland
5 Security and Governmental Affairs of the Sen-
6 ate.

7 (e) TERMINATION.—Section 1013(a)(2) of title 5,
8 United States Code, shall not apply to the Board.

9 (f) FUNDING.—

10 (1) AUTHORIZATION OF APPROPRIATIONS.—
11 There is authorized to be appropriated \$10,000,000
12 to carry out this section, to remain available until
13 expended.

14 (2) ADDITIONAL FUNDING.—In addition to the
15 amounts made available pursuant to paragraph (1),
16 the Federal members of the Board may, for pur-
17 poses of carrying out this section, use amounts
18 whose purpose is not otherwise specified by the ap-
19 propriations laws available to the employing agencies
20 of such members.
