Mr. HUFFMAN (for himself, Mr. COHEN, Ms. DELBENE, Ms. NORTON, Mr. MIN, Ms. SCHAKOWSKY, and Ms. BROWNLEY) introduced the following bill; which was referred to the Committee on Natural Resources, and in addition to the Committee on Agriculture, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To prohibit the use of M–44 devices, commonly known as
“cyanide bombs”, on public land, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as “Canyon’s Law”.

5 **SEC. 2. FINDINGS.**

6 Congress finds the following:

7 (1) Sodium cyanide is the highly toxic pesticide
8 active ingredient used in M–44 devices, also known

1 as “cyanide bombs”, and is used to kill coyotes,
2 foxes, and wild dogs suspected of preying on live-
3 stock and poultry.

4 (2) Sodium cyanide is registered for restricted
5 use under the Federal Insecticide, Fungicide, and
6 Rodenticide Act (7 U.S.C. 136 et seq.) as a Cat-
7 egory One acute toxicant, the most hazardous Envi-
8 ronmental Protection Agency classification available,
9 due to the harm it poses to people and the environ-
10 ment.

11 (3) Poisoning by sodium cyanide leads to cen-
12 tral nervous system depression, cardiac arrest, res-
13 piratory failure, paralysis, and blindness.

14 (4) The Environmental Protection Agency au-
15 thorizes the use of M-44 devices nationwide, and in
16 recent years, M-44s were used in Colorado, Mon-
17 tana, North Dakota, Nebraska, New Mexico, Ne-
18 vada, Oklahoma, Texas, West Virginia, and Wyo-
19 ming.

20 (5) In 2017, an M-44 device exposed an Idaho
21 child to a sublethal dose of sodium cyanide with sub-
22 sequent short-term and long-term medical complica-
23 tions. Two Wyoming children were also exposed to
24 the poison from another M-44 device. Three family
25 dogs died in these two separate incidents.

1 (6) More than 50 family dogs have been docu-
2 mented as killed by M-44 devices since 1990, and
3 the full count is estimated to be significantly higher.

4 (7) The indiscriminate M-44 device commonly
5 harms nontarget wildlife and people; at least 42 peo-
6 ple have accidentally triggered a cyanide bomb caus-
7 ing exposure to cyanide gas and injuries since 1984.

8 (8) A Utah man, who was poisoned by an M-
9 44 in 2003 and permanently disabled, died in 2018
10 with cyanide poisoning from exposure to an M-44
11 device listed as a contributing cause of death on his
12 death certificate.

13 (9) M-44 devices kill targeted animals only 53
14 percent of the time. Thousands of nontarget species
15 of animals have been killed by M-44s, including bald
16 eagles, golden eagles, gray wolves, black bears, griz-
17 zly bears, bobcats, fishers, and family dogs.

18 (10) Despite the United States Fish and Wild-
19 life Service determining in 1993 that M-44 devices
20 could kill endangered species like the California Con-
21 dor, the use of the M-44 continues in areas where
22 endangered species are found and continues to result
23 in the deaths of endangered species.

1 **SEC. 3. USE OF M-44 DEVICES ON PUBLIC LAND PROHIB-**
2 **ITED.**

3 (a) IN GENERAL.—Preparing, placing, installing, set-
4 ting, deploying, or otherwise using an M-44 device on
5 public land is prohibited.

6 (b) REMOVAL.—Not later than 30 days after the date
7 of the enactment of this Act, any Federal, State, or county
8 agency that has prepared, placed, installed, set, or de-
9 ployed an M-44 device on public land shall remove each
10 such M-44 device from public land.

11 (c) DEFINITIONS.—In this Act:

12 (1) M-44 DEVICE.—

13 (A) IN GENERAL.—The term “M-44 de-
14 vice” means a device designed to propel sodium
15 cyanide when triggered by an animal.

16 (B) COMMON NAMES.—The term “M-44
17 device” includes any device that may be com-
18 monly known as an “M-44 ejector device” or
19 an “M-44 predator control device”.

20 (2) PUBLIC LAND.—The term “public land”
21 means any Federal land under the administrative ju-
22 risdiction of a public land management agency.

23 (3) PUBLIC LAND MANAGEMENT AGENCY.—The
24 term “public land management agency” means each
25 of, or a combination of, the following:

26 (A) The National Park Service.

1 (B) The United States Fish and Wildlife
2 Service.

3 (C) The Bureau of Land Management.

4 (D) The Bureau of Reclamation.

5 (E) The Forest Service.
