Mr. WEBSTER of Florida introduced the following bill; which was referred to the Committee on Science, Space, and Technology

## A BILL

To restrict the obligation or expenditure of Federal funds relating to certain Chinese space and scientific activities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Frank Wolf Space Se-  
5 curity Act”.

6 **SEC. 2. RESTRICTION ON FEDERAL FUNDS RELATING TO**  
7 **CERTAIN CHINESE SPACE AND SCIENTIFIC**  
8 **ACTIVITIES.**

9 (a) IN GENERAL.—No Federal funds may be obli-  
10 gated or expended for the following:

1           (1) For the National Aeronautics and Space  
2           Administration (NASA), the Office of Science and  
3           Technology Policy (OSTP), or the National Space  
4           Council (NSpC) to develop, design, plan, promul-  
5           gate, implement, or execute a bilateral policy, pro-  
6           gram, order, or contract of any kind to participate,  
7           collaborate, or coordinate bilaterally in any way with  
8           the People’s Republic of China or any Chinese-  
9           owned company unless such activities are specifically  
10          authorized by a law enacted after the date of the en-  
11          actment of this Act.

12          (2) To effectuate the hosting of official Chinese  
13          visitors at Federal facilities belonging to or utilized  
14          by NASA.

15          (b) EXCEPTIONS.—The restrictions described in sub-  
16          section (a) shall not apply to activities with respect to  
17          which NASA, OSTP, or NSpC, after consultation with the  
18          Federal Bureau of Investigation, have certified—

19                (1) pose no risk of resulting in the transfer of  
20                technology, data, or other information with national  
21                security or economic security implications to the  
22                People’s Republic of China or a Chinese-owned com-  
23                pany; and

24                (2) will not involve knowing interactions with  
25                officials who have been determined by the United

1 States to have direct involvement with violations of  
2 human rights.

3 (c) SUBMISSION.—Any certification made under sub-  
4 section (b) shall be submitted to the Committee on  
5 Science, Space, and Technology and the Committee on Ap-  
6 propriations of the House of Representatives, the Com-  
7 mittee on Commerce, Science, and Transportation and the  
8 Committee on Appropriations of the Senate, and the Fed-  
9 eral Bureau of Investigation, not later than 30 days prior  
10 to the activity in question. Any such certification shall in-  
11 clude a description of the purpose of such activity, its  
12 agenda, its major participants, and its location and tim-  
13 ing.
