# **A BILL**

To modify the boundary of the Vicksburg National Military  
Park in the State of Mississippi, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Vicksburg National Mili-*  
 5 *tary Park Boundary Modification Act”.*

6 **SEC. 2. VICKSBURG NATIONAL MILITARY PARK CONVEY-**  
 7 **ANCE AND BOUNDARY MODIFICATION.**

8 *(a) CONVEYANCE.—*

9 *(1) IN GENERAL.—The Secretary of the Interior*  
 10 *(referred to in this Act as the “Secretary”) shall con-*  
 11 *vey to the State of Mississippi (referred to in this Act*  
 12 *as the “State”), by quitclaim deed and without con-*  
 13 *sideration, the Federal land described in paragraph*  
 14 *(2) to be used in accordance with subsection (c).*

15 *(2) DESCRIPTION OF FEDERAL LAND.—The Fed-*  
 16 *eral land referred to in paragraph (1) is the fol-*  
 17 *lowing:*

18 *(A) The parcel of approximately 1.69 acres*  
 19 *of Federal land within the boundary of Vicks-*  
 20 *burg National Military Park (referred to in this*  
 21 *Act as the “Park”), as depicted on the map enti-*  
 22 *tled “Vicksburg National Military Park Proposed*  
 23 *Disposal of a Portion of NPS Tract 01-103”,*  
 24 *numbered 306/194,908, and dated September*  
 25 *2024.*

1           (B) *The parcel of approximately 5.74 acres*  
2           *of Federal land within the boundary of the Park,*  
3           *as depicted on the map entitled “Vicksburg Na-*  
4           *tional Military Park Proposed Disposal of a*  
5           *Portion of NPS Tracts Near Union Ave”, num-*  
6           *bered 306/194,907, and dated September 2024.*

7           (b) *BOUNDARY MODIFICATION.—On conveyance of the*  
8           *Federal land described in subsection (a), the Secretary shall*  
9           *modify the boundary of the Park to exclude the Federal land*  
10          *conveyed.*

11          (c) *USE OF LANDS.—The Federal land conveyed to the*  
12          *State under this Act—*

13               (1) *shall be used to facilitate public access to the*  
14               *Park and to enhance the visitor experience at the*  
15               *Park in a manner consistent with the interpretative*  
16               *mission of the Park, as determined by the Secretary;*

17               (2) *shall not be used in a manner that adversely*  
18               *impacts Park resources or the Park visitor experience,*  
19               *as determined by the Secretary; and*

20               (3) *shall be subject to any use restriction the Sec-*  
21               *retary determines to be appropriate.*
