## A BILL

To amend the Arms Export Control Act to modify the authorities relating to the Special Defense Acquisition Fund.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Accelerate Revenue  
5 for Manufacturing and Sales Act” or the “ARMS Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

8 (1) The United States defense industrial base  
9 plays a critical role in advancing both security and  
10 prosperity.

1           (2) There is increasing global demand for  
2           United States manufactured defense capabilities,  
3           highlighting the need to maintain a strong, agile,  
4           and scalable defense production capacity.

5           (3) In recent years, the combined value of For-  
6           eign Military Sales (FMS) and Direct Commercial  
7           Sales (DCS) has significantly exceeded domestic de-  
8           fense procurement budgets, with international de-  
9           mand for United States defense products approach-  
10          ing two-to-one over domestic acquisition.

11          (4) Delays in delivering defense articles to allied  
12          and partner nations expose vulnerabilities in the cur-  
13          rent acquisition and sales process that risks under-  
14          mining United States strategic credibility abroad.

15          (5) The Special Defense Acquisition Fund  
16          (SDAF) has demonstrated effectiveness in reducing  
17          delivery times and enabling advanced contracting for  
18          high-demand defense items prior to the completion  
19          of formal agreements.

20          (6) Strengthening and expanding the SDAF  
21          would increase the efficiency and predictability of  
22          defense article deliveries to foreign partners, support  
23          the United States defense industrial base, and im-  
24          prove economies of scale.

1           (7) Timely access to United States defense sys-  
2       tems by allies and partners strengthens interoper-  
3       ability, improves coalition readiness, deters shared  
4       threats, and reinforces long-standing strategic rela-  
5       tionships.

6           (8) Enhancing SDAF authorities and capacity  
7       aligns with United States national interests and sup-  
8       ports continued leadership in the global defense mar-  
9       ket.

10 **SEC. 3. MODIFICATIONS TO SPECIAL DEFENSE ACQUISI-**  
11 **TION FUND.**

12       Section 51(b)(1) of the Arms Export Control Act (22  
13 U.S.C. 2795(b)(1)) is amended by striking “sales made  
14 under” and all that follows through “the actual value” and  
15 inserting “sales”.
