A BILL

To amend title XIX of the Social Security Act to require coverage for certain individual with breast or cervical cancer under the Medicaid program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Medicaid Breast Can-
5 cer Access to Treatment Act”.

1 **SEC. 2. REQUIRING MEDICAID COVERAGE FOR CERTAIN IN-**
 2 **DIVIDUALS WITH BREAST OR CERVICAL CAN-**
 3 **CER UNDER THE MEDICAID PROGRAM.**

4 (a) IN GENERAL.—Section 1902 of the Social Secu-
 5 rity Act (42 U.S.C. 1396a) is amended—

6 (1) in subsection (a)(10)—

7 (A) in subparagraph (A)—

8 (i) in the matter preceding clause (i),
 9 by striking “and (30)” and inserting
 10 “(30), and (32)”;

11 (ii) in clause (i)—

12 (I) in subclause (VIII), by strik-
 13 ing “or” at the end;

14 (II) in subclause (IX), by adding
 15 “or” at the end; and

16 (III) by adding at the end the
 17 following new subclause:

18 “(X) who are described in subsection
 19 (aa) (relating to certain breast or cervical
 20 cancer patients);”; and

21 (iii) in clause (ii), by striking sub-
 22 clause (XVIII); and

23 (B) in the matter at the end, in subdivision
 24 (XIV), by striking “subparagraph
 25 (A)(10)(ii)(XVIII)” and inserting “subpara-
 26 graph (A)(10)(i)(X)”;

1 (2) in subsection (aa)—

2 (A) by striking paragraphs (1) and (2);

3 (B) by redesignating paragraphs (3) and

4 (4) as paragraphs (1) and (2), respectively; and

5 (C) in paragraph (2), as so redesignated,

6 by inserting “as in effect on the day before the

7 date of the enactment of the Patient Protection

8 and Affordable Care Act,” after “(42 U.S.C.

9 300gg(c)),”.

10 (b) INCLUSION OF BREAST RECONSTRUCTION AS

11 MEDICAL ASSISTANCE.—Section 1905(a) of the Social Se-

12 curity Act (42 U.S.C. 1396d(a)) is amended—

13 (1) in paragraph (31), by striking “and” at the

14 end;

15 (2) by redesignating paragraph (32) as para-

16 graph (33); and

17 (3) by inserting after paragraph (31) the fol-

18 lowing new paragraph:

19 “(32) breast reconstruction following a medi-

20 cally necessary mastectomy; and”.

21 (c) CONFORMING AMENDMENTS.—

22 (1) FMAP.—Section 1905(b)(4) of the Social

23 Security Act (42 U.S.C. 1396d(b)(4)) is amended by

24 striking “section 1902(a)(10)(A)(ii)(XVIII)” and in-

25 serting “section 1902(a)(10)(A)(i)(X)”.

1 (2) COST SHARING.—

2 (A) IN GENERAL.—Subsections (a)(2) and
3 (b)(2) of section 1916 of the Social Security
4 Act (42 U.S.C. 1396o) are each amended—

5 (i) in subparagraph (I), by striking
6 “or” at the end;

7 (ii) in subparagraph (J), by striking
8 “; and” at the end and inserting “, or”;
9 and

10 (iii) by adding at the end the fol-
11 lowing new subparagraph:

12 “(K) items and services furnished to individuals
13 described in section 1902(aa); and”.

14 (B) ALTERNATIVE COST SHARING.—Sec-
15 tion 1916A(b)(3) of the Social Security Act (42
16 U.S.C. 1396o–1(b)(3)) is amended—

17 (i) in subparagraph (A)(v), by striking
18 “1902(a)(10)(A)(ii)(XVIII)” and inserting
19 “1902(a)(10)(A)(i)(X)”;

20 (ii) in subparagraph (B)(viii), by
21 striking “1902(a)(10)(A)(ii)(XVIII)” and
22 inserting “1902(a)(10)(A)(i)(X)”.

1 (d) EFFECTIVE DATE.—The amendments made by
2 this section shall apply beginning 1 year after the date
3 of the enactment of this Act.
