## A BILL

To amend title XVIII of the Social Security Act to require the provision of certain information with respect to breast reconstruction surgery under the Medicare program.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Medicare Breast Re-  
3 construction Access and Information Act”.

4 **SEC. 2. REQUIRING THE PROVISION OF CERTAIN INFORMA-**  
5 **TION WITH RESPECT TO BREAST RECON-**  
6 **STRUCTION SURGERY.**

7 Section 1834 of the Social Security Act (42 U.S.C.  
8 1395m) is amended by adding at the end the following  
9 new subsection:

10 “(aa) **REQUIREMENT TO PROVIDE CERTAIN INFOR-**  
11 **MATION WITH RESPECT TO BREAST RECONSTRUCTION**  
12 **SURGERY.**—Notwithstanding any other provision of this  
13 part, no payment may be made under this part for a mas-  
14 tectomy furnished to an individual on or after the date  
15 that is 1 year after the date of the enactment of this sub-  
16 section unless the supplier furnishing such mastectomy,  
17 prior to the furnishing of such mastectomy—

18 “(1) informs such individual that breast recon-  
19 struction surgery following a medically necessary  
20 mastectomy is covered under this part pursuant to  
21 national coverage determination 140.2; and

22 “(2) documents the provision of such informa-  
23 tion in the medical record of such individual.”.
