Mr. FLOOD (for himself and Mr. CARTER of Louisiana) introduced the following bill; which was referred to the Committee on Energy and Commerce

A BILL

To make publicly available information on sustainable aviation fuel production and imports, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Sustainable Aviation
5 Fuel Information Act”.

6 **SEC. 2. REPORTED DATA.**

7 (a) REPORTED DATA.—As soon as practicable after
8 the date of enactment of this Act, the Secretary of Energy,
9 acting through the Administrator of the Energy Informa-
10 tion Administration, shall include in each report titled

1 “Petroleum Supply Monthly” of the Energy Information
2 Administration, each report titled “Weekly Petroleum Sta-
3 tus Report” of the Energy Information Administration,
4 and any other relevant report of the Energy Information
5 Administration, as determined by the Administrator of the
6 Energy Information Administration, data on sustainable
7 aviation fuel, including—

8 (1) the type, origin, and volume of feedstock
9 used in the production of sustainable aviation fuel—

10 (A) in each State or, if appropriate, Petro-
11 leum Administration for Defense District, as
12 applicable;

13 (B) in the United States; and

14 (C) to the maximum extent practicable, in
15 each foreign country, as applicable; and

16 (2) the total amount of sustainable aviation
17 fuel—

18 (A) produced—

19 (i) in each State, as applicable; and

20 (ii) in the United States; and

21 (B) imported from—

22 (i) each foreign country, as applicable;

23 and

24 (ii) all foreign countries, as applicable.

1 (b) REPORTING REQUIREMENTS.—Data published
2 pursuant to this section shall be obtained using an ac-
3 counting methodology that—

4 (1) is consistent with reliable statistical sam-
5 pling techniques; and

6 (2) ensures no double counting of feedstock or
7 fuel.

8 (c) RULE OF CONSTRUCTION.—Nothing in this sec-
9 tion affects the applicability of section 205 of the Depart-
10 ment of Energy Organization Act (42 U.S.C. 7135).

11 **SEC. 3. DEFINITION OF SUSTAINABLE AVIATION FUEL.**

12 In this Act, the term “sustainable aviation fuel” has
13 the meaning given such term in section 40B(d) of the In-
14 ternal Revenue Code of 1986.
