# **A BILL**

To direct the Secretary of Agriculture to issue a special use permit with respect to the maintaining of a flagpole bearing the flag of the United States at Kyhv Peak Lookout Point, Utah, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Star-Spangled Summit*  
 5 *Act of 2026”.*

6 **SEC. 2. SPECIAL USE PERMIT FOR INSTALLATION, OPER-**  
 7 **ATION, MAINTENANCE, AND REMOVAL OF**  
 8 **COVERED FLAGPOLE AT KYHV PEAK LOOK-**  
 9 **OUT POINT.**

10 (a) *DEFINITIONS.—In this section:*

11 (1) *COVERED FLAGPOLE.—The term “covered*  
 12 *flagpole” means a flagpole bearing the flag of the*  
 13 *United States.*

14 (2) *KYHV PEAK LOOKOUT POINT.—The term*  
 15 *“Kyhv Peak Lookout Point” means the peak within*  
 16 *the Uinta National Forest overlooking Utah Valley*  
 17 *and located approximately at latitude 40°16′18.14”*  
 18 *N, longitude 111°36′58.57” W.*

19 (3) *QUALIFIED PERSON.—The term “qualified*  
 20 *person” means an individual that resides in, or a*  
 21 *nonprofit entity or volunteer organization that carries*  
 22 *out operations of the entity or organization in, Utah*  
 23 *County, Utah, that has—*

24 (A) *experience placing, maintaining, or oth-*  
 25 *erwise caring for a covered flagpole; and*

1           (B) any other experience determined rel-  
2           evant by the Secretary.

3           (4) *SECRETARY.*—The term “Secretary” means  
4           the Secretary of Agriculture, acting through the Chief  
5           of the Forest Service.

6           (b) *SPECIAL USE PERMIT.*—Not later than 180 days  
7           after the date of enactment of this Act and notwithstanding  
8           any other provision of law, the Secretary shall issue a spe-  
9           cial use permit for a period of 10 years for the installation,  
10          operation, maintenance, and removal, if necessary, of a cov-  
11          ered flagpole at Kyhv Peak Lookout Point to—

12           (1) an individual who has submitted a special  
13          use permit application to display the flag of the  
14          United States seasonally on Kyhv Peak prior to  
15          March 5, 2026;

16           (2) an individual who has placed or displayed  
17          the flag of the United States at Kyhv Peak Lookout  
18          Point as part of a longstanding seasonal practice  
19          prior to the date of enactment of this Act; or

20           (3) if an individual described in paragraphs (1)  
21          and (2) declines such permit, to a qualified person in  
22          accordance with this section.

23          (c) *SELECTION AND ISSUANCE.*—

24           (1) *APPLICATION.*—Except as provided in sub-  
25          section (b), to be eligible to be selected for a special

1        *use permit under this section, a qualified person shall*  
2        *submit to the Secretary a proposal and application at*  
3        *such time, in such manner, and containing such in-*  
4        *formation as the Secretary may require.*

5            (2) *TERMS AND CONDITIONS.—The Secretary*  
6        *may impose such terms and conditions on a holder of*  
7        *a special use permit under this section as the Sec-*  
8        *retary determines necessary to ensure the proper care*  
9        *and maintenance of a covered flagpole.*

10           (3) *LAND USE FEE EXEMPTION.—The Secretary*  
11        *shall not assess any land use fees with respect to a*  
12        *special use permit issued under this section.*

13           (4) *NOTICE OF APPLICATION.—The Secretary*  
14        *shall publish notice of the availability of any special*  
15        *use permit under this section on the website of the*  
16        *Forest Service and in a local Utah County, Utah,*  
17        *newspaper of record.*

18           (d) *SUBSEQUENT SPECIAL USE PERMITS.—*

19            (1) *IN GENERAL.—The Secretary shall renew or*  
20        *issue a new 10-year special use permit not later than*  
21        *180 days after the date that is the earliest of the fol-*  
22        *lowing:*

23            (A) *The date that is 10 years after the date*  
24            *on which the Secretary issued the preceding per-*  
25            *mit.*

1           (B) *The date on which the holder of the cur-*  
2           *rent special use permit requests revocation of*  
3           *such permit.*

4           (C) *The date on which a special use permit*  
5           *is subject to early termination under paragraph*  
6           *(2).*

7           (2) *REVOCATION.—If the Secretary determines*  
8           *that the holder of a special use permit under this sec-*  
9           *tion is not in compliance with the terms and condi-*  
10          *tions relating to such permit under subsection (c)(3),*  
11          *the Secretary may revoke the special use permit.*

12          (e) *EXEMPTION FROM COST RECOVERY FEES.—A*  
13          *holder of a special use permit under this section shall be*  
14          *exempt from any cost recovery fee under section 251.58 of*  
15          *title 36, Code of Federal Regulations.*

16          (f) *APPLICABILITY OF NEPA.—The National Environ-*  
17          *mental Policy Act of 1969 (42 U.S.C. 4321 et seq.) shall*  
18          *not apply to the issuance, renewal, or administration of*  
19          *a special use permit under this section, including any ac-*  
20          *tivities associated with the placing, maintenance, or re-*  
21          *moval of a covered flagpole at Kyhv Peak Lookout Point.*

22          (g) *ACCESS.—The Secretary may authorize reasonable*  
23          *access to Kyhv Peak Lookout Point for the purpose of exer-*  
24          *cising rights under a special use permit issued under this*

1 *section, subject to conditions necessary to protect public*  
2 *safety and natural resources.*

3       *(h) LIMITATION.—The Secretary shall ensure the ac-*  
4 *tivities and access authorized by this section are limited*  
5 *to the smallest practicable area.*
