A BILL

To amend the Federal Fire Prevention and Control Act of 1974 to require annual reports to Congress regarding courses and programs offered by the Academy, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Fire Academy
5 Reporting Act”.

1 **SEC. 2. ANNUAL REPORT REGARDING COURSES AND PRO-**
2 **GRAMS OFFERED BY THE NATIONAL ACAD-**
3 **EMY FOR FIRE PREVENTION AND CONTROL.**

4 Section 7 of the Federal Fire Prevention and Control
5 Act of 1974 (15 U.S.C. 2206) is amended—

6 (1) by redesignating subsection (n) as sub-
7 section (o); and

8 (2) by inserting after subsection (m) the fol-
9 lowing new subsection:

10 “(n) ANNUAL REPORT.—Not later than November
11 30 of every year beginning with November 30 of the first
12 full year that occurs after the date of the enactment of
13 this subsection, the Administrator shall submit to Con-
14 gress a report regarding courses and programs offered by
15 the Academy during the immediately preceding fiscal year.
16 Each such report shall include information relating to the
17 following:

18 “(1) The total number of fire departments with
19 personnel who attended a course or program offered
20 by the Academy, disaggregated by the following:

21 “(A) An identification of such fire depart-
22 ments.

23 “(B) An identification of the States in
24 which such fire departments are located.

25 “(2) The total number of fire department per-
26 sonnel who attended a course or program offered by

1 the Academy, disaggregated by the status of such
2 personnel as either career or volunteer firefighters.

3 “(3) The total number of courses and programs
4 offered by the Academy.

5 “(4) The total number of courses and programs
6 cancelled by the Academy.

7 “(5) The total amount of funds awarded under
8 subsection (f), disaggregated as follows:

9 “(A) To State fire service training pro-
10 grams.

11 “(B) To local fire service training pro-
12 grams.

13 “(6) The total amount of funds awarded under
14 subsection (i) to students attending courses or pro-
15 grams offered by the Academy.”.
