3 **SECTION 1. EXTENSION OF SBIR AND STTR AUTHORITY.**

4 (a) SBIR.—Section 9(m) of the Small Business Act
5 (15 U.S.C. 638(m)) is amended by striking “September
6 30, 2025” and inserting “September 30, 2026”.

7 (b) STTR.—Section 9(n)(1)(A) of the Small Busi-
8 ness Act (15 U.S.C. 638(n)(1)(A)) is amended by striking
9 “through fiscal year 2025” and inserting “though fiscal
10 year 2026”.

11 **SEC. 2. EXTENSION OF SBIR AND STTR PROGRAMS AND AC-**
12 **TIVITIES.**

13 (a) PHASE FLEXIBILITY.—Section 9(cc) of the Small
