A BILL

To establish a program to Beautify the District of Columbia
and establish the District of Columbia Safe and Beau-
tiful Commission.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Make the District of*
5 *Columbia Safe and Beautiful Act of 2026”.*

6 **SEC. 2. PROGRAM TO BEAUTIFY DISTRICT OF COLUMBIA.**

7 *(a) ESTABLISHMENT.—*

8 *(1) IN GENERAL.—Not later than 30 days after*
9 *the date of the enactment of this section, the Secretary*
10 *of the Interior (hereinafter the “Secretary”) shall de-*
11 *velop a program to beautify the District of Columbia*
12 *(hereinafter the “Program”).*

13 *(2) CONSULTATION.—The Secretary, when estab-*
14 *lishing the Program, shall consult with each of the fol-*
15 *lowing:*

16 *(A) The Attorney General.*

17 *(B) The Secretary of Transportation.*

18 *(C) The Mayor of the District of Columbia.*

19 *(D) The United States Attorney for the Dis-*
20 *trict of Columbia.*

21 *(E) The Administrator of General Services.*

22 *(F) The heads of such other Federal depart-*
23 *ments and agencies and District of Columbia of-*
24 *ficials as the Secretary deems appropriate.*

1 (b) *PURPOSE.*—*The purpose of the Program is to es-*
2 *tablish a plan for Federal and local officials to—*

3 (1) *coordinate, and maintain, the cleanliness, of*
4 *Federal and District of Columbia facilities, monu-*
5 *ments, land, public spaces, sidewalks, parks, high-*
6 *ways, roads, transit systems, and other commonly vis-*
7 *ited areas within the District of Columbia, including*
8 *through the removal of graffiti;*

9 (2) *restore Federal public monuments, memo-*
10 *rials, statues, markers, and similar properties that*
11 *have been damaged or defaced or inappropriately re-*
12 *moved or changed; and*

13 (3) *encourage private-sector participation in the*
14 *efforts of the Program.*

15 (c) *REPORT.*—*Not later than 1 year after the date of*
16 *the enactment of this section, and annually thereafter, the*
17 *Secretary shall submit a report to the Committees on Over-*
18 *sight and Government Reform and on Natural Resources*
19 *of the House of Representatives and the Committees on*
20 *Homeland Security and Governmental Affairs and on En-*
21 *ergy and Natural Resources of the Senate that includes a*
22 *summary of the progress made toward achieving the pur-*
23 *pose of the Program as described in subsection (b).*

24 (d) *SUNSET.*—*This section, and the Program estab-*
25 *lished by this section, shall terminate on January 2, 2029.*

1 **SEC. 3. DISTRICT OF COLUMBIA SAFE AND BEAUTIFUL COM-**
2 **MISSION.**

3 (a) *ESTABLISHMENT.*—*There is established in the exec-*
4 *utive branch a District of Columbia Safe and Beautiful*
5 *Commission (hereafter the “Commission”).*

6 (b) *MEMBERSHIP.*—

7 (1) *IN GENERAL.*—*The Commission shall be com-*
8 *prised of representatives of each of the following enti-*
9 *ties:*

10 (A) *The Department of the Interior.*

11 (B) *The Department of Transportation.*

12 (C) *The Department of Homeland Security.*

13 (D) *The Federal Bureau of Investigation.*

14 (E) *The United States Marshals Service.*

15 (F) *The Bureau of Alcohol, Tobacco, Fire-*
16 *arms and Explosives.*

17 (G) *The United States Attorney’s Office for*
18 *the District of Columbia.*

19 (H) *The United States Attorney’s Office for*
20 *the District of Maryland.*

21 (I) *The United States Attorney’s Office for*
22 *the Eastern District of Virginia.*

23 (J) *Such other entities of the Federal Gov-*
24 *ernment as may be determined by the Chair of*
25 *the Commission.*

1 (2) *DESIGNATION OF MEMBERS.*—Not later than
 2 45 days after the date of the enactment of this section
 3 (or, in the case of an entity described in subsection
 4 (b)(1)(J), not later than 45 days after the Chair of
 5 the Commission designates the entity), the head of
 6 each entity described in subsection (b)(1) shall des-
 7 ignate a representative of that entity to serve as the
 8 representative of the entity on the Commission.

9 (c) *CHAIR.*—

10 (1) *DESIGNATION.*—Not later than 45 days after
 11 the date of the enactment of this section, the President
 12 shall designate a senior level official from the Execu-
 13 tive Office of the President to serve as the Chair of
 14 the Commission.

15 (2) *FUNCTIONS.*—The Chair shall perform func-
 16 tions that include the following:

17 (A) *Developing a schedule of meetings for*
 18 *the Commission.*

19 (B) *Designating entities who shall be rep-*
 20 *resented on the Commission under subsection*
 21 *(b)(1)(J).*

22 (C) *In consultation with the members of the*
 23 *Commission, developing a charter for the Com-*
 24 *mission and, not later than 7 days after the date*
 25 *on which the charter is completed, submitting the*

1 *charter to the appropriate committees of Con-*
2 *gress.*

3 (d) *FUNCTIONS AND AUTHORITIES.—*

4 (1) *FUNCTIONS.—The functions of the Commis-*
5 *sion are to recommend actions, and review the effec-*
6 *tiveness of such actions, with respect to the following:*

7 (A) *Developing and encouraging the imple-*
8 *mentation of policies which will direct the max-*
9 *imum enforcement of Federal immigration law*
10 *within the District of Columbia, including poli-*
11 *cies to encourage the redirection of available*
12 *Federal, State, or local law enforcement resources*
13 *to apprehend and deport illegal aliens.*

14 (B) *Monitoring the District of Columbia's*
15 *sanctuary-city status and compliance with the*
16 *enforcement of Federal immigration law.*

17 (C) *Facilitating the prompt and complete*
18 *accreditation of the District of Columbia's foren-*
19 *sic crime laboratory.*

20 (D) *In collaboration with its leadership and*
21 *union, ensuring that the Metropolitan Police De-*
22 *partment of the District of Columbia is provided*
23 *with assistance to facilitate the recruitment, re-*
24 *tention, and capabilities of its officers and facili-*

1 *tating the provision of Federal personnel, re-*
2 *sources, and expertise to reduce crime.*

3 *(E) Collaborating with appropriate local*
4 *government entities to provide assistance to in-*
5 *crease the speed and lower the cost of processing*
6 *concealed carry license requests in the District of*
7 *Columbia.*

8 *(F) Reviewing and, as appropriate, recom-*
9 *mending revisions to Federal prosecutorial poli-*
10 *cies on pretrial detention of criminal defendants*
11 *to ensure that individuals who pose a genuine*
12 *threat to public safety are detained to the max-*
13 *imum extent permitted by law.*

14 *(G) Collaborating with appropriate local*
15 *government entities to provide assistance to end*
16 *fare evasion and other crime within the Wash-*
17 *ington Metropolitan Area Transit Authority sys-*
18 *tem.*

19 *(H) Facilitating the deployment of a more*
20 *robust Federal law enforcement presence, and in*
21 *coordination with local law enforcement agen-*
22 *cies, facilitating the deployment of a more robust*
23 *local law enforcement presence (as appropriate)*
24 *within the District of Columbia, including the*
25 *National Mall and Memorial Parks, museums,*

1 *monuments, Lafayette Park, Union Station,*
2 *Rock Creek Park, Anacostia Park, the George*
3 *Washington Memorial Parkway, the Suitland*
4 *Parkway, and the Baltimore-Washington Park-*
5 *way.*

6 (2) *COORDINATION WITH OTHER AUTHORI-*
7 *TIES.—The Commission may, to the extent permitted*
8 *by law, request operational assistance from and co-*
9 *ordinate with Federal and local officials as appro-*
10 *priate, including the Metropolitan Police Department*
11 *of the District of Columbia, the Washington Metro-*
12 *politan Area Transit Authority, the United States*
13 *Park Police, and the Amtrak Police.*

14 (e) *REPORT.—The Commission shall submit a report*
15 *to the appropriate committees of Congress which includes*
16 *a summary of the functions and authorities carried out*
17 *pursuant to subsection (d), and shall include in the report*
18 *such recommendations for legislation as the Commission*
19 *considers appropriate.*

20 (f) *APPROPRIATE COMMITTEES OF CONGRESS DE-*
21 *FINED.—In this section, the term “appropriate committees*
22 *of Congress” means—*

23 (1) *the Committee on Oversight and Government*
24 *Reform of the House of Representatives; and*

1 (2) *the Committee on Homeland Security and*
2 *Governmental Affairs of the Senate.*

3 (g) *SUNSET.—This section, and the Commission estab-*
4 *lished by this section, shall terminate on January 2, 2029.*

5 **SECTION 1. SHORT TITLE.**

6 **This Act may be cited as the “Make the**

9 **SEC. 2. PROGRAM TO BEAUTIFY DISTRICT OF COLUMBIA.**

10 **(a) ESTABLISHMENT.—**

11 **(1) IN GENERAL.—Not later than 30**
12 **days after the date of the enactment of**
13 **this section, the Secretary of the Interior**
14 **(hereinafter the “Secretary”) shall de-**

17 **(2) CONSULTATION.—The Secretary,**
18 **when establishing the Program, shall**
19 **consult with each of the following:**

20 **(A) The Attorney General.**

21 **(B) The Secretary of Transpor-**
22 **tation.**

23 **(C) The Mayor of the District of**
24 **Columbia.**

1 **(D) The United States Attorney**
2 **for the District of Columbia.**

3 **(E) The Administrator of General**
4 **Services.**

5 **(F) The heads of such other Fed-**
6 **eral departments and agencies and**
7 **District of Columbia officials as the**
8 **Secretary deems appropriate.**

9 **(b) PURPOSE.—The purpose of the Pro-**
10 **gram is to establish and implement a plan for**
11 **Federal and local officials to—**

12 **(1) coordinate, and maintain, the**
13 **cleanliness, of Federal and District of Co-**
14 **lumbia facilities, monuments, land, public**
15 **spaces, sidewalks, parks, highways,**
16 **roads, transit systems, and other com-**
17 **monly visited areas within the District of**
18 **Columbia, including through the removal**
19 **of graffiti;**

20 **(2) restore, to the extent practicable,**
21 **District of Columbia and Federal public**
22 **monuments, memorials, statues, markers,**
23 **and similar properties that have been**
24 **damaged or defaced or inappropriately**
25 **removed or changed; and**

1 **(3) encourage private-sector partici-**
2 **pation in the efforts of the Program.**

3 **(c) REPORT.—Not later than 1 year after**
4 **the date of the enactment of this section, and**
5 **annually thereafter, the Secretary shall sub-**
6 **mit a report to the Committees on Oversight**
7 **and Government Reform and on Natural Re-**
8 **sources of the House of Representatives and**
9 **the Committees on Homeland Security and**
10 **Governmental Affairs and on Energy and Nat-**
11 **ural Resources of the Senate that includes a**
12 **summary of the progress of the Program and**
13 **the plan as described in subsection (b).**

14 **(d) SUNSET.—This section, and the Pro-**
15 **gram established by this section, shall termi-**
16 **nate on January 2, 2029.**

17 **SEC. 3. DISTRICT OF COLUMBIA SAFE AND BEAUTIFUL**
18 **COMMISSION.**

19 **(a) ESTABLISHMENT.—There is established**
20 **in the executive branch a District of Columbia**
21 **Safe and Beautiful Commission (hereafter the**
22 **“Commission”).**

23 **(b) MEMBERSHIP.—**

1 **(1) IN GENERAL.—The Commission**
2 **shall be comprised of representatives of**
3 **each of the following entities:**

4 **(A) The Department of the Inte-**
5 **rior.**

6 **(B) The Department of Transpor-**
7 **tation.**

8 **(C) The Department of Homeland**
9 **Security.**

10 **(D) The Federal Bureau of Inves-**
11 **tigation.**

12 **(E) The United States Marshals**
13 **Service.**

14 **(F) The Bureau of Alcohol, To-**
15 **bacco, Firearms and Explosives.**

16 **(G) The United States Attorney's**
17 **Office for the District of Columbia.**

18 **(H) The United States Attorney's**
19 **Office for the District of Maryland.**

20 **(I) The United States Attorney's**
21 **Office for the Eastern District of Vir-**
22 **ginia.**

23 **(J) The Executive Office of the**
24 **Mayor of the District of Columbia (as**
25 **defined in section 3(3) of the Govern-**

1 **mental Reorganization Procedures**
2 **Act of 1981; sec. 1-315.02(3), D.C. Offi-**
3 **cial Code).**

4 **(K) Such other entities of the Fed-**
5 **eral government as may be deter-**
6 **mined by the Chair of the Commis-**
7 **sion.**

8 **(2) DESIGNATION OF MEMBERS.—Not**
9 **later than 45 days after the date of the**
10 **enactment of this section (or, in the case**
11 **of an entity described in subsection**
12 **(b)(1)(K), not later than 45 days after the**
13 **Chair of the Commission designates the**
14 **entity), the head of each entity described**
15 **in subsection (b)(1) shall designate a rep-**
16 **resentative of that entity to serve as the**
17 **representative of the entity on the Com-**
18 **mission.**

19 **(c) CHAIR.—**

20 **(1) DESIGNATION.—Not later than 45**
21 **days after the date of the enactment of**
22 **this section, the President shall designate**
23 **a senior level official from the Executive**
24 **Office of the President to serve as the**
25 **Chair of the Commission.**

1 **(2) FUNCTIONS.—The Chair shall per-**
2 **form functions that include the following:**

3 **(A) Developing a schedule of**
4 **meetings for the Commission.**

5 **(B) Designating entities who shall**
6 **be represented on the Commission**
7 **under subsection (b)(1)(K).**

8 **(C) In consultation with the mem-**
9 **bers of the Commission, developing a**
10 **charter for the Commission and, not**
11 **later than 7 days after the date on**
12 **which the charter is completed, sub-**
13 **mitting the charter to the appro-**
14 **priate committees of Congress.**

15 **(d) FUNCTIONS AND AUTHORITIES.—**

16 **(1) FUNCTIONS.—The functions of the**
17 **Commission are to recommend actions,**
18 **and review the effectiveness of such ac-**
19 **tions, with respect to, but not limited to,**
20 **the following:**

21 **(A) Developing and encouraging**
22 **the implementation of polices which**
23 **will direct the maximum enforcement**
24 **of Federal immigration law within**
25 **the District of Columbia, including**

1 policies to encourage the redirection
2 of available Federal, State, or local
3 law enforcement resources to apprehend and deport illegal aliens.

5 (B) Monitoring the District of Co-
6 lumbia's sanctuary-city status and
7 compliance with the enforcement of
8 Federal immigration law.

9 (C) Facilitating the prompt and
10 complete accreditation of the District
11 of Columbia's forensic crime labora-
12 tory.

13 (D) In collaboration with its lead-
14 ership and union, ensuring that the
15 Metropolitan Police Department of
16 the District of Columbia is provided
17 with assistance to facilitate the re-
18 cruitment, retention, and capabilities
19 of its officers and facilitating the pro-
20 vision of Federal personnel, re-
21 sources, and expertise to reduce
22 crime.

23 (E) Collaborating with appro-
24 priate local government entities to
25 provide assistance to increase the

1 speed and lower the cost of proc-
2 essing concealed carry license re-
3 quests in the District of Columbia.

4 (F) Reviewing and, as appro-
5 priate, recommending revisions to
6 Federal prosecutorial policies on pre-
7 trial detention of criminal defendants
8 to ensure that individuals who pose a
9 genuine threat to public safety are
10 detained to the maximum extent per-
11 mitted by law.

12 (G) Collaborating with appro-
13 priate local government entities to
14 provide assistance to end fare eva-
15 sion and other crime within the
16 Washington Metropolitan Area Tran-
17 sit Authority system.

18 (H) Facilitating the deployment of
19 a more robust Federal law enforce-
20 ment presence, and in coordination
21 with local law enforcement agencies,
22 facilitating the deployment of a more
23 robust local law enforcement pres-
24 ence (as appropriate) within the Dis-
25 trict of Columbia, including the Na-

1 tional Mall and Memorial Parks, mu-
2 seums, monuments, Lafayette Park,
3 Union Station, Rock Creek Park, Ana-
4 costia Park, the George Washington
5 Memorial Parkway, the Suitland
6 Parkway, and the Baltimore-Wash-
7 ington Parkway.

8 (2) COORDINATION WITH OTHER AU-
9 THORITIES.—The Commission may, to the
10 extent permitted by law, request oper-
11 ational assistance from and coordinate
12 with Federal and local officials as appro-
13 priate, including the Metropolitan Police
14 Department of the District of Columbia,
15 the Washington Metropolitan Area Tran-
16 sit Authority, and the Amtrak Police.

17 (e) REPORT.—The Commission shall sub-
18 mit a report to the appropriate committees of
19 Congress which includes a summary of the
20 functions and authorities carried out pursu-
21 ant to subsection (d), and shall include in the
22 report such recommendations for legislation
23 as the Commission considers appropriate.

1 **(f) APPROPRIATE COMMITTEES OF CONGRESS**
2 **DEFINED.—In this section, the term “appro-**
3 **priate committees of Congress” means—**

4 **(1) the Committee on Oversight and**
5 **Government Reform of the House of Rep-**
6 **resentatives; and**

7 **(2) the Committee on Homeland Secu-**
8 **urity and Governmental Affairs of the Sen-**
9 **ate.**

10 **(g) SUNSET.—This section, and the Com-**
11 **mission established by this section, shall ter-**
12 **minate on January 2, 2029.**
