A BILL

To repeal the Comprehensive Policing and Justice Reform Amendment Act of 2022 enacted by the District of Columbia Council.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Common-Sense Law En-*
5 *forcement and Accountability Now in DC Act of 2025” or*
6 *the “CLEAN DC Act of 2025”.*

7 **SEC. 2. REPEAL OF CERTAIN PROVISIONS OF COMPREHEN-**
8 **SIVE POLICING AND JUSTICE REFORM**
9 **AMENDMENT ACT OF 2022.**

10 *(a) IN GENERAL.—Except as provided in subsection*
11 *(b), the Comprehensive Policing and Justice Reform*
12 *Amendment Act of 2022 (D.C. Law 24–345) is hereby re-*
13 *pealed, and any provision of law amended or repealed by*
14 *such Act is restored or revived as if such Act had not been*
15 *enacted into law.*

16 *(b) EXCEPTION.—The repeal under subsection (a) shall*
17 *not apply with respect to—*

18 *(1) subtitle S of title I of such Act (sec. 5–365.01*
19 *et seq., D.C. Official Code); and*

20 *(2) subtitle A of title I of such Act (sec. 5–125.01*
21 *et seq. and sec. 5–302, D.C. Official Code).*
