A BILL

To amend title XVIII of the Social Security Act to ensure stability in payments to home health agencies under the Medicare program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Home Health Sta-
5 bilization Act of 2025”.

1 **SEC. 2. ENSURING BENEFICIARY ACCESS TO MEDICARE**
2 **HOME HEALTH SERVICES.**

3 (a) DELAYING ADJUSTMENTS.—Section
4 1895(b)(3)(D) of the Social Security Act (42 U.S.C.
5 1395fff(b)(3)(D)) is amended by adding at the end the
6 following new clauses:

7 “(iv) SPECIAL RULE FOR 2026 AND
8 2027.—For 2026 and 2027, the Secretary
9 shall provide for a positive adjustment to
10 the standard prospective payment amount
11 to fully offset the –4.059 percent Perma-
12 nent Adjustment Factor and the –5.0 per-
13 cent Temporary Adjustment Factor ap-
14 plied to the calendar year 2026 national,
15 standardized 30-day period payment rate
16 in the proposed rule entitled, ‘Medicare
17 and Medicaid Programs; Calendar Year
18 2026 Home Health Prospective Payment
19 System (HH PPS) Rate Update; Require-
20 ments for the HH Quality Reporting Pro-
21 gram and the HH Value-Based Purchasing
22 Expanded Model; Durable Medical Equip-
23 ment, Prosthetics, Orthotics, and Supplies
24 (DMEPOS) Competitive Bidding Program
25 Updates; DMEPOS Accreditation Require-
26 ments; Provider Enrollment; and Other

1 Medicare and Medicaid Policies’ published
2 in the Federal Register on July 2, 2025
3 (90 Fed. Reg. 29108). Notwithstanding
4 any other provision of law, the Secretary
5 may implement this clause by program in-
6 struction or otherwise.

7 “(v) SPECIAL RULE FOR 2026 AND
8 2027.—For 2026 and 2027, the Secretary
9 shall establish the national, standardized
10 30-day period payment rate based on the
11 2025 rate, taking into account the adjust-
12 ment under clause (iv) and updated based
13 on all other provisions of this section, ex-
14 cept that such rate for 2026 or 2027 shall
15 not be further adjusted based on clause (ii)
16 or clause (iii).

17 “(vi) EXCEPTION.—In determining
18 actual expenditures under clause (i) for
19 2026 and 2027 the Secretary shall exclude
20 the additional amounts paid as a result of
21 clauses (iv) and (v), and no adjustments
22 under clause (ii) or clause (iii) shall be
23 made to offset for such amounts.”.

24 (b) CONSTRUCTION.—Nothing in this section shall be
25 construed as signifying congressional approval or dis-

1 approval of the methodology promulgated by the Secretary
2 to implement section 1895(b)(3)(D) of the Social Security
3 Act in the final rule entitled, “Medicare Program; Cal-
4 endar Year (CY) 2023 Home Health Prospective Payment
5 System Rate Update; Home Health Quality Reporting
6 Program Requirements; Home Health Value-Based Pur-
7 chasing Expanded Model Requirements; and Home Infu-
8 sion Therapy Services Requirements” published in the
9 Federal Register on November 4, 2022 (87 Fed. Reg.
10 66790).
