## A BILL

To amend the National Institute of Standards and Technology Act to require the periodic update to the strategic plan to guide the Manufacturing USA Program to align with the mandatory updates to the National Strategy for Advanced Manufacturing.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Streamlining American  
5 Manufacturing Strategy Act”.

1 **SEC. 2. ALIGNMENT OF TIMING OF UPDATES OF STRA-**  
2 **TEGIC PLAN WITH UPDATES TO NATIONAL**  
3 **STRATEGY FOR ADVANCED MANUFAC-**  
4 **TURING.**

5 (a) IN GENERAL.—Paragraph (2) of section 34(i) of  
6 the National Institute of Standards and Technology Act  
7 (15 U.S.C. 278s(i)) is amended—

8 (1) in subparagraph (C), by striking “and up-  
9 date not less frequently than once every 3 years  
10 thereafter,”;

11 (2) by redesignating subparagraphs (D)  
12 through (M) as subparagraphs (E) through (N), re-  
13 spectively; and

14 (3) by inserting after subparagraph (C), the fol-  
15 lowing:

16 “(D) to update the strategic plan devel-  
17 oped under subparagraph (C) not less fre-  
18 quently than once every 4 years such that the  
19 planning cycle for the updates aligns with the  
20 planning cycle for updates to the National  
21 Strategy for Advanced Manufacturing required  
22 under section 102(c)(4) of the America COM-  
23 PETES Reauthorization Act of 2010 (42  
24 U.S.C. 6622(c)(4)) to better ensure the Pro-  
25 gram reflects the priorities of the national  
26 strategy;”.

1 (b) CONFORMING AMENDMENTS.—Such section is  
2 further amended—

3 (1) in paragraph (3), by striking “paragraph  
4 (2)(C)” and inserting “subparagraphs (C) and (D)  
5 of paragraph (2)”; and

6 (2) in paragraph (4), by striking “paragraph  
7 (2)(C)” and inserting “subparagraph (C) of para-  
8 graph (2) and any update to the plan required under  
9 subparagraph (D) of such paragraph”.
