Mr. CROW (for himself and Mr. CRANK) introduced the following bill; which was referred to the Committee on Foreign Affairs

A BILL

To require the Secretary of Defense to initiate discussions, through the Quad, with Australia, India, and Japan to identify mutual areas of interest with respect to the formulation of best practices in space, cooperation on space situational awareness, and space industrial policy, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Quad Space Act”.

1 **SEC. 2. SPACE COOPERATION AMONG QUAD COUNTRIES.**

2 (a) SENSE OF CONGRESS.—It is the sense of Con-
3 gress that—

4 (1) as a Pacific power, the United States should
5 strengthen cooperation with the Government of Aus-
6 tralia, the Government of India, and the Govern-
7 ment of Japan to address regional challenges and
8 promote a free and open Indo-Pacific region;

9 (2) the United States should expand coopera-
10 tion, through the Quad, with the Government of
11 Australia, the Government of India, and the Govern-
12 ment of Japan to address shared security challenges,
13 particularly in space; and

14 (3) the revival of the Quad by President Donald
15 J. Trump and the elevation of the Quad to the lead-
16 ers' level by President Joseph R. Biden were critical
17 steps in advancing shared interests in the Indo-Pa-
18 cific region.

19 (b) DETERMINATION OF AREAS OF MUTUAL INTER-
20 EST IN SPACE.—

21 (1) IN GENERAL.—Not later than 180 days
22 after the date of the enactment of this Act, the Sec-
23 retary of Defense shall seek to initiate discussions,
24 through the Quad, with the Government of Aus-
25 tralia, the Government of India, and the Govern-

1 ment of Japan to identify areas of mutual interest
2 with respect to—

3 (A) the formulation of best practices in
4 space;

5 (B) cooperation on space situational
6 awareness; and

7 (C) space industrial policy.

8 (2) REPORT.—Not later than 270 days after
9 the date of the enactment of this Act, the Secretary
10 of Defense shall submit to the Committees of Armed
11 Services of the Senate and the House of Representa-
12 tives a report on the discussions under paragraph
13 (1), including—

14 (A) a detailed description of potential
15 areas of mutual interest identified through such
16 discussions; and

17 (B) an identification of potential steps the
18 Secretary intends to take to formalize coopera-
19 tion, though the Quad, among the United
20 States, Australia, India, and Japan.

21 (c) DEFINITIONS.—In this section:

22 (1) QUAD.—The term “Quad” means the part-
23 nership among the Quad countries.

24 (2) QUAD COUNTRIES.—The term “Quad coun-
25 tries” means the following:
