# **A BILL**

To require the Social Security Administration to make changes to the social security terminology used in the rules, regulation, guidance, or other materials of the Administration.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Claiming Age Clarity*  
5       *Act”.*

6       **SEC. 2. CHANGES TO SOCIAL SECURITY TERMINOLOGY.**

7       *Not later than the later of the date that is 12 months*  
8       *after the date of enactment of this Act or January 1, 2027,*  
9       *the Commissioner of Social Security shall ensure that, in*  
10       *any rules, regulation, guidance, or other materials of the*  
11       *Social Security Administration, whether online or in*  
12       *print—*

13               (1) *the term “early eligibility age” is replaced*  
14       *with the term “minimum monthly benefit age”;*

15               (2) *the terms “full retirement age” and “normal*  
16       *retirement age” are replaced with the term “standard*  
17       *monthly benefit age”; and*

18               (3) *the term “delayed retirement credit” shall*  
19       *not be used and any reference to age 70 as the max-*  
20       *imum age up to which delayed retirement credits can*  
21       *be received shall be replaced with the term “maximum*  
22       *monthly benefit age”.*
