## A BILL

To amend title 38, United States Code, to provide for a limitation on the amount of entitlement to educational assistance payable for flight training under the Post-9/11 Educational Assistance Program of the Department of Veterans Affairs.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veterans Flight Train-  
5 ing Responsibility Act of 2025”.

1 **SEC. 2. LIMITATION ON AMOUNT OF ENTITLEMENT TO**  
2 **EDUCATIONAL ASSISTANCE PAYABLE FOR**  
3 **FLIGHT TRAINING UNDER POST-9/11 EDU-**  
4 **CATIONAL ASSISTANCE PROGRAM OF DE-**  
5 **PARTMENT OF VETERANS AFFAIRS.**

6 (a) IN GENERAL.—Section 3313 of title 38, United  
7 States Code, is amended—

8 (1) in subsection (g)(3)(C), by striking “In the  
9 case” and inserting “Subject to the limitation under  
10 subsection (m), in the case”; and

11 (2) by adding at the end the following new sub-  
12 section:

13 “(m) LIMITATION ON USE OF ENTITLEMENT FOR  
14 FLIGHT TRAINING.—

15 “(1) LIMITATION.—Notwithstanding any other  
16 provision of this chapter, the maximum total amount  
17 payable under this chapter for flight training fees in  
18 the case of an individual pursuing a program of a  
19 flight training offered by a public institution of high-  
20 er learning is \$100,000, as increased under para-  
21 graph (2).

22 “(2) ANNUAL PERCENTAGE INCREASE.—With  
23 respect to any fiscal year, the Secretary shall provide  
24 a percentage increase (rounded to the nearest dollar)  
25 in the maximum amount of payable under paragraph  
26 (1), equal to the percentage by which—

1           “(A) the Consumer Price Index (all items,  
2           United States city average) for the 12-month  
3           period ending on the June 30 preceding the be-  
4           ginning of the fiscal year for which the increase  
5           is made, exceeds

6           “(B) the Consumer Price Index for the 12-  
7           month period preceding the 12-month period  
8           described in subparagraph (A).”.

9           (b) APPLICABILITY.—The amendments made by sub-  
10          section (a) shall apply with respect to an individual who  
11          first pursues a program of flight training on or after Au-  
12          gust 1, 2026.
