A BILL

To amend title 28, United States Code, to change the residency requirements for certain officials serving in the District of Columbia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “District of Columbia
5 Federal Judicial Officials Residency Equality Act of
6 2025”.

1 **SEC. 2. RESIDENCY REQUIREMENTS FOR CERTAIN OFFI-**
2 **CIALS SERVING IN THE DISTRICT OF COLUM-**
3 **BIA.**

4 (a) **CIRCUIT JUDGES.**—Section 44(c) of title 28,
5 United States Code, is amended—

6 (1) by striking “Except in the District of Co-
7 lumbia, each” and inserting “Each”;

8 (2) by striking “his appointment” and inserting
9 “his or her appointment”; and

10 (3) by striking “state” and inserting “State”.

11 (b) **DISTRICT JUDGES.**—Section 134 of title 28,
12 United States Code, is amended—

13 (1) in the first sentence of subsection (b)—

14 (A) by striking “the District of Columbia,
15 the Southern District of New York, and” and
16 inserting “the Southern District of New York
17 and”; and

18 (B) by striking “for which he” and insert-
19 ing “for which he or she”; and

20 (2) in subsection (c), by striking “his” each
21 place it appears and inserting “his or her”.

22 (c) **UNITED STATES ATTORNEYS.**—Section 545(a) of
23 title 28, United States Code, is amended by striking the
24 first sentence and inserting “Each United States attorney
25 shall reside in the district for which he or she is appointed,
26 except that those officers of the Southern District of New

1 York and the Eastern District of New York may reside
2 within 20 miles thereof.”.

3 (d) UNITED STATES MARSHALS.—Section 561(e)(1)
4 of title 28, United States Code, is amended to read as
5 follows:

6 “(1) the marshal for the Southern District of
7 New York may reside within 20 miles of the district;
8 and”.

9 (e) CLERKS.—Section 751(e) of title 28, United
10 States Code, is amended by striking “District of Columbia
11 and the”.

12 (f) EFFECTIVE DATE.—The amendments made by
13 this section shall apply only to individuals appointed after
14 the date of the enactment of this Act.
