# **A BILL**

To amend the Small Business Act to require small business development centers to assist small business concerns with the use of artificial intelligence, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “AI for Main Street Act”.*

5 **SEC. 2. GUIDANCE ON THE USE OF ARTIFICIAL INTEL-**  
6 **LIGENCE FOR SMALL BUSINESS CONCERNS.**

7        *(a) IN GENERAL.—Section 21(c)(3) of the Small Busi-*  
8 *ness Act (15 U.S.C. 648(c)(3)) is amended—*

9            *(1) in subparagraph (T), by striking “and” at*  
10 *the end;*

11            *(2) in the first subparagraph (U) (relating to en-*  
12 *couraging and assisting the provision of succession*  
13 *planning), by striking the period at the end and in-*  
14 *serting a semicolon;*

15            *(3) by redesignating the second subparagraph*  
16 *(U) (relating to providing training in conjunction*  
17 *with the United States Patent and Trademark Office)*  
18 *as subparagraph (V);*

19            *(4) in subparagraph (V), as so redesignated, by*  
20 *striking the period at the end and inserting “; and”;*  
21 *and*

22            *(5) by adding at the end the following new sub-*  
23 *paragraph:*

1           “(W) assisting small business concerns in evalu-  
2           ating artificial intelligence concerning operations, in-  
3           cluding by—

4                   “(i) providing information, guidance, and  
5                   training to small business concerns on the use of  
6                   artificial intelligence, including—

7                           “(I) best practices for using artificial  
8                           intelligence;

9                           “(II) using artificial intelligence to  
10                          plan for unexpected circumstances, protect  
11                          data and intellectual property, improve cy-  
12                          bersecurity, facilitate regulatory compli-  
13                          ance, and improve customer trust; and

14                          “(III) incorporating artificial intel-  
15                          ligence into business operations; and

16                          “(ii) conducting outreach to the extent prac-  
17                          tical to small business concerns regarding the use  
18                          of artificial intelligence.”.

19           (b) *CONFORMING AMENDMENT.*—Section 3 of the  
20 *Small Business Act (15 U.S.C. 632)* is amended by adding  
21 *at the end the following new subsection:*

22                   “(gg) *ARTIFICIAL INTELLIGENCE.*—In this Act, the  
23 *term ‘artificial intelligence’ has the meaning given such*  
24 *term in section 5002 of the National Artificial Intelligence*  
25 *Initiative Act of 2020 (15 U.S.C. 9401).”.*

3 *Act or the amendments made by this Act.*
