A BILL

To adjust the treatment of certain actions under Presidential Determination 2022–11 for Federal permitting improvement, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Critical Minerals Sup-*
 5 *ply Chain Resiliency Act of 2026”.*

6 **SEC. 2. TREATMENT OF ACTIONS UNDER PRESIDENTIAL DE-**
 7 **TERMINATION 2022–11 FOR FEDERAL PERMIT-**
 8 **TING IMPROVEMENT PURPOSES.**

9 *(a) IN GENERAL.—Except as provided by subsection*
 10 *(c), an action described in subsection (b) shall be—*

11 *(1) treated as a covered project, as defined in*
 12 *section 41001(6) of the Fixing America’s Surface*
 13 *Transportation Act (42 U.S.C. 4370m(6)), without*
 14 *regard to the requirements of that section; and*

15 *(2) included in the Permitting Dashboard main-*
 16 *tained pursuant to section 41003(b) of that Act (42*
 17 *U.S.C. 4370m–2(b)).*

18 *(b) ACTIONS DESCRIBED.—An action described in this*
 19 *subsection is an action taken by the Secretary of Defense*
 20 *pursuant to Presidential Determination 2022–11 (87 Fed.*
 21 *Reg. 19775; relating to certain actions under section 303*
 22 *of the Defense Production Act of 1950) to create, maintain,*
 23 *protect, expand, or restore sustainable and responsible do-*
 24 *mestic production capabilities for strategic and critical ma-*
 25 *terials through—*

1 (1) *supporting feasibility studies for mature*
2 *mining, beneficiation, and value-added processing*
3 *projects;*

4 (2) *by-product and co-product production at ex-*
5 *isting mining, mine waste reclamation, and other in-*
6 *dustrial facilities;*

7 (3) *modernization of mining, beneficiation, and*
8 *value-added processing to increase productivity, envi-*
9 *ronmental sustainability, and workforce safety; or*

10 (4) *any other activity authorized under section*
11 *303(a)(1) of the Defense Production Act of 1950 (50*
12 *U.S.C. 4533(a)(1)).*

13 (c) *EXCEPTION.—An action described in subsection (b)*
14 *may not be treated as a covered project or be included in*
15 *the Permitting Dashboard under subsection (a) if the*
16 *project sponsor (as defined in section 41001(18) of the Fix-*
17 *ing America’s Surface Transportation Act (42 U.S.C.*
18 *4370m(18))) requests that the action not be treated as a*
19 *covered project.*
