Mr. MOORE of West Virginia (for himself, Mrs. MILLER of West Virginia, Mr. AMODEI of Nevada, and Mr. SIMPSON) introduced the following bill; which was referred to the Committee on Natural Resources, and in addition to the Committees on Homeland Security, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To transfer administrative jurisdiction over certain parcels
of federal land in Harpers Ferry, West Virginia, and
for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TRANSFER OF FEDERAL LAND IN HARPERS**
4 **FERRY, WEST VIRGINIA.**

5 (a) TRANSFER FROM DOI TO CBP.—

6 (1) IN GENERAL.—Administrative jurisdiction
7 over the approximately 25 acres of Federal land in

1 Harpers Ferry, West Virginia, generally depicted as
2 “Area to be Transferred to CBP” on the Map, is
3 transferred from the Secretary to the Commissioner.

4 (2) ADMINISTRATION.—The land transferred
5 under paragraph (1) shall be administered as part of
6 U.S. Customs and Border Protection’s Advanced
7 Training Center in accordance with applicable law.

8 (3) EXCLUSION FROM HARPERS FERRY NA-
9 TIONAL HISTORICAL PARK.—The Secretary shall ad-
10 just the boundaries of the Park to exclude the land
11 transferred under paragraph (1).

12 (4) LAND SURVEY.—The Commissioner—

13 (A) shall obtain a survey to finalize the
14 exact acreage and legal description of the parcel
15 of Federal land transferred under paragraph
16 (1);

17 (B) in consultation with the Secretary,
18 may modify any clerical or typographical errors
19 in the legal description and maps of the land;
20 and

21 (C) upon completion of the survey, shall
22 provide a complete copy of the survey to the
23 Secretary.

24 (b) TRANSFER FROM CBP TO DOI.—

1 (1) IN GENERAL.—Administrative jurisdiction
2 over the approximately 71.51 acres of Federal land
3 in Harpers Ferry, West Virginia generally depicted
4 as “Area to be Transferred to NPS” on the Map is
5 transferred from the Commissioner to the Secretary.

6 (2) ADMINISTRATION.—The land transferred
7 under paragraph (1) shall be administered as part of
8 the Park, and the Secretary shall adjust the bound-
9 aries of the Park to reflect the inclusion of the land
10 under this subsection.

11 (c) NO REIMBURSEMENT OF CONSIDERATION.—The
12 transfer of land under this Act shall be without monetary
13 reimbursement or additional consideration.

14 (d) REVERSION AND RESTORATION.—

15 (1) IN GENERAL.—If the Commissioner deter-
16 mines that the land or a portion of the land trans-
17 ferred under subsection (a) is not required for the
18 U.S. Customs and Border Protection’s Advanced
19 Training Center, administrative jurisdiction of such
20 land or portion of land shall revert to the Secretary
21 in a manner and condition acceptable to the Sec-
22 retary.

23 (2) INCLUSION IN PARK.—Any land with re-
24 spect to which administrative jurisdiction reverts to
25 the Secretary under paragraph (1) shall be adminis-

1 tered as a part of the Park, and the Secretary shall
2 adjust the boundaries of the Park to reflect the in-
3 clusion of such land under this subsection.

4 (e) BOUNDARY LIMITATION.—The acreage limitation
5 in section 1(d) of the Act of June 30, 1944 (16 U.S.C.
6 450bb(d)), shall not apply to the land transferred under
7 this Act (including by reversion under subsection (d)).

8 (f) DEFINITIONS.—In this Act:

9 (1) MAP.—The term “Map” means the map
10 published by the National Park Service titled
11 “Harpers Ferry National Historical Park Proposed
12 Land Transfers”, numbered 385/176,677, and dated
13 May 2021.

14 (2) COMMISSIONER.—The term “Commis-
15 sioner” means the Commissioner of U.S. Customs
16 and Border Protection.

17 (3) PARK.—The term “Park” means Harpers
18 Ferry National Historical Park.

19 (4) SECRETARY.—The term “Secretary” means
20 the Secretary of the Interior.
