Ms. RIVAS (for herself, Mr. FIELDS, Mr. WALKINSHAW, and Mr. THANEDAR) introduced the following bill; which was referred to the Committee on Science, Space, and Technology

A BILL

To establish in the Office of Science and Technology Policy the Artificial Intelligence Literacy and Education Commission, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Artificial Intelligence
5 for Advancing Literacy and Learning Act” or the “AI for
6 ALL Act”.

1 **SEC. 2. ESTABLISHMENT OF THE ARTIFICIAL INTEL-**
2 **LIGENCE LITERACY AND EDUCATION COM-**
3 **MISSION.**

4 (a) **IN GENERAL.**—There is established in the Office
5 of Science and Technology Policy a commission to be
6 known as the “Artificial Intelligence Literacy and Edu-
7 cation Commission”.

8 (b) **MEMBERSHIP.**—The members of the Commission
9 shall be composed of the following:

10 (1) The Director of the Office of Science and
11 Technology Policy, who shall serve as the Chair-
12 person.

13 (2) A representative of the Office of Manage-
14 ment and Budget with expertise in AI, appointed by
15 the Director of such Office.

16 (3) A representative of the National Science
17 Foundation with expertise in AI, appointed by the
18 Director of such Foundation.

19 (4) A representative of the Department of Com-
20 merce with expertise in AI, appointed by the Sec-
21 retary of Commerce.

22 (5) A representative of the Department of Edu-
23 cation with expertise in AI, appointed by the Sec-
24 retary of Education.

1 (6) A representative of the Department of
2 Labor with expertise in AI, appointed by the Sec-
3 retary of Labor.

4 (7) A representative of the General Services Ad-
5 ministration with expertise in AI, appointed by the
6 Administrator of General Services.

7 (8) An individual with AI expertise appointed
8 by the Chairperson from an institution of higher
9 education that is leading advanced research of AI.

10 (9) An individual with AI expertise appointed
11 by the Chairperson from a private sector entity.

12 (10) An individual appointed by the Chair-
13 person from an organization that develops AI lit-
14 eracy recommendations.

15 (c) MEETINGS.—

16 (1) REGULAR MEETINGS.—The Commission
17 shall hold, at the call of the Chairperson, at least
18 one meeting every three months. The Commission
19 may hold, at the call of the Chairperson, such other
20 meetings as the Chairperson determines appropriate.

21 (2) INITIAL MEETING.—The Commission shall
22 hold the first meeting of the Commission not later
23 than 60 days after the date of the enactment of this
24 Act.

1 (d) DUTIES OF THE COMMISSION.—In addition to the
2 duties of the Commission under sections 3 and 4, the
3 Commission shall carry out the following:

4 (1) Streamline, improve, and augment AI lit-
5 eracy and education as the Chairperson determines
6 necessary for the ability of persons in the United
7 States to effectively and efficiently utilize AI.

8 (2) To the extent practicable, coordinate and
9 promote AI literacy and education efforts at the
10 State and local level, including by promoting part-
11 nerships among Federal, State, and local govern-
12 ments, nonprofit organizations, institutions of higher
13 education, research institutions, and private sector
14 entities.

15 (e) NON-TERMINATION; EXEMPTION FROM CHARTER
16 REQUIREMENT.—Section 1013 of title 5, United States
17 Code, shall not apply to the Commission.

18 **SEC. 3. DEVELOPMENT AND DISSEMINATION OF MATE-**
19 **RIALS.**

20 The Commission shall carry out the following:

21 (1) Develop multilingual materials and re-
22 sources promoting AI literacy and education in the
23 United States.

24 (2) Disseminate to the general public such ma-
25 terials and resources in any form or manner the

1 Chairperson determines appropriate, which may in-
2 clude any of the following:

3 (A) Establishing a publicly available
4 website that contains such materials and re-
5 sources.

6 (B) Conducting a multilingual national
7 public service multimedia campaign.

8 **SEC. 4. NATIONAL STRATEGY FOR AI LITERACY AND EDU-**
9 **CATION.**

10 (a) IN GENERAL.—Not later than one year after the
11 date of the enactment of this Act, the Commission shall
12 carry out the following:

13 (1) Develop a national strategy for the Federal
14 Government to carry out the following:

15 (A) Identify the opportunities and chal-
16 lenges for the Federal Government with respect
17 to improving the AI literacy and education of
18 persons in the United States.

19 (B) In accordance with such identifica-
20 tions, improve such literacy and education, in-
21 cluding by ensuring such persons understand
22 the following:

23 (i) AI.

24 (ii) How AI has evolved and is ex-
25 pected to evolve.

1 (iii) How to utilize AI safely and ef-
2 fectively.

3 (C) Ensure such improvements enable for
4 the United States continued global leadership in
5 AI.

6 (2) Submit to Congress such strategy.

7 (b) SUBSEQUENT STRATEGIES.—

8 (1) IN GENERAL.—Not later than six months
9 after submitting the strategy pursuant to subsection
10 (a) and biennially thereafter, the Chairperson shall
11 determine whether such strategy is outdated.

12 (2) UPDATES.—If the Chairperson, pursuant to
13 paragraph (1) or (3), as the case may be, makes
14 such a determination in the affirmative, the Com-
15 mission shall submit to Congress an updated strat-
16 egy that includes any changes the Chairperson de-
17 termines necessary.

18 (3) FURTHER DETERMINATIONS.—If an up-
19 dated strategy is submitted under paragraph (2),
20 not later than two years after such submission and
21 biennially thereafter, the Chairperson shall make a
22 determination described in paragraph (1).

23 (c) COORDINATION.—The Commission shall, as ap-
24 propriate, coordinate the efforts of the Federal Govern-

1 ment to implement a strategy submitted under this sec-
2 tion.

3 **SEC. 5. DEFINITIONS.**

4 In this Act:

5 (1) AI.—The term “AI” has the meaning given
6 the term “artificial intelligence” in section 238(g) of
7 the John S. McCain National Defense Authorization
8 Act for Fiscal Year 2019 (10 U.S.C. 4061 note
9 prec.).

10 (2) CHAIRPERSON.—The term “Chairperson”
11 means the Chairperson of the Commission.

12 (3) COMMISSION.—The term “Commission”
13 means the Artificial Intelligence Literacy and Edu-
14 cation Commission established under section 2.

15 (4) INSTITUTION OF HIGHER EDUCATION.—The
16 term “institution of higher education” has the
17 meaning given such term in section 101 of the High-
18 er Education Act of 1965 (20 U.S.C. 1001).
