A BILL

To provide for an extension of funding outreach and assistance for low-income programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Senior Savings Protec-
5 tion Act”.

1 **SEC. 2. EXTENSION OF FUNDING OUTREACH AND ASSIST-**
2 **ANCE FOR LOW-INCOME PROGRAMS.**

3 (a) STATE HEALTH INSURANCE ASSISTANCE PRO-
4 GRAMS.—Subsection (a)(1)(B) of section 119 of the Medi-
5 care Improvements for Patients and Providers Act of 2008
6 (42 U.S.C. 1395b–3 note) is amended—

7 (1) in clause (xiii), by striking “and” at the
8 end;

9 (2) in clause (xiv), by striking the period at the
10 end and inserting “; and”; and

11 (3) by inserting after clause (xiv) the following
12 new clause:

13 “(xv) for each of fiscal years 2026
14 through 2030, \$15,000,000.”.

15 (b) AREA AGENCIES ON AGING.—Subsection
16 (b)(1)(B) of such section 119 is amended—

17 (1) in clause (xiii), by striking “and” at the
18 end;

19 (2) in clause (xiv), by striking the period at the
20 end and inserting “; and”; and

21 (3) by inserting after clause (xiv) the following
22 new clause:

23 “(xv) for each of fiscal years 2026
24 through 2030, \$15,000,000.”.

25 (c) AGING AND DISABILITY RESOURCE CENTERS.—
26 Subsection (c)(1)(B) of such section 119 is amended—

1 (1) in clause (xiii), by striking “and” at the
2 end;

3 (2) in clause (xiv), by striking the period at the
4 end and inserting “; and”; and

5 (3) by inserting after clause (xiv) the following
6 new clause:

7 “(xv) for each of fiscal years 2026
8 through 2030, \$5,000,000.”.

9 (d) COORDINATION OF EFFORTS TO INFORM OLDER
10 AMERICANS ABOUT BENEFITS AVAILABLE UNDER FED-
11 ERAL AND STATE PROGRAMS.—Subsection (d)(2) of such
12 section 119 is amended—

13 (1) in clause (xiii), by striking “and” at the
14 end;

15 (2) in clause (xiv), by striking the period at the
16 end and inserting “; and”; and

17 (3) by inserting after clause (xiv) the following
18 new clause:

19 “(xv) for each of fiscal years 2026
20 through 2030, \$15,000,000.”.
